**RESOLUTION BY THE PUBLIC WORKS, PARKS AND FACILITIES COMMITTEE
AUTHORIZING THE EXECUTION OF A CONTRACT WITH THE BROWN'S LAKE SKI
CLUB**

To the Honorable Members of the Racine County Board of Supervisors:

BE IT RESOLVED by the Racine County Board of Supervisors that the execution of a contract with the Brown's Lake Ski Club (a/k/a Aquaducks) for the year 2008 is hereby authorized and approved. A summary of the major provisions of said contract is contained in Exhibit "A" which is attached hereto and incorporated herein. The actual contract shall be negotiated and approved by the Corporation Counsel and the Public Works Director and upon execution, shall be filed with the County Clerk.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that any two of the County Clerk, the County Executive and/or the County Board Chairman are authorized to execute any contracts, agreements or other documents necessary to carry out the intent of this resolution.

22 **BROWN'S LAKE SKI CLUB AND RACINE COUNTY**

- 24 1. The Ski Club will be allowed to use certain portions of Fischer Park for ski shows
25 and demonstration.
26
27 2. Ski Club will clean up and maintain the areas of Fischer Park involved with the Ski
28 Club shows and practices during the times that they are using the site.

30 3. Ski Club shall maintain general liability insurance in the amount of \$1 million and
31 name Racine County as an additional insured.

33 4. Ski Club shall indemnify and hold Racine County harmless for all claims, causes of
34 action, lawsuits and damages arising out of Ski Club's actions or omissions at
35 Fischer Park.

37 5. The contract shall be for a one (1) year period beginning January 1, 2008 but can
38 be renewed by mutual written agreement of the parties on a yearly basis. Either
39 party can terminate the agreement upon sixty (60) days written notice.
