INFORMATION ONLY

WHEREAS, the Racine County Board of Supervisors previously authorized in Resolution No. 2007-78 for the Sheriff's Department to contract with other government entities for temporary housing in the Racine County Jail; and

WHEREAS, the Racine County Sheriff ("Sheriff") has had multi-level discussions with the United States Department of Homeland Security - Immigration and Customs Enforcement ("ICE") for the temporary housing of ICE detainees; and

WHEREAS, the federal reimbursement rate for ICE detainees is higher than the State of Wisconsin reimbursement rate for Department of Corrections inmates, and a transportation reimbursement is also provided by ICE; and

WHEREAS, the Sheriff is required to provide secured transportation for detainees on all trips to and from any designated federal detention facility; and

WHEREAS, the Sheriff has had multi-level discussions with a Racine-based security contractor that can provide qualified skilled security personnel that the Sheriff would deputize and that would meet the federal requirements set out in the ICE agreement; and

WHEREAS, the Sheriff expects that the transportation vehicles used for this project will incur high mileage and therefore agrees with the Finance Director that it would be more cost effective to purchase used transportation vans for this project; and

WHEREAS, it is anticipated that the agreement with ICE for the temporary housing of their detainees will bring the Sheriff's Department closer to meeting the revenue goals that were set out in Resolution 2007-78.
