**RESOLUTION BY THE PUBLIC WORKS, PARKS AND FACILITIES COMMITTEE
AUTHORIZING THE SALE OF EXCESS RIGHT OF WAY ALONG CTH "K" IN THE TOWN
OF NORWAY**

To the Honorable Members of the Racine County Board of Supervisors:

BE IT RESOLVED by the Racine County Board of Supervisors that the County is authorized to offer for sale two (2) remnants of land along CTH "K" as identified in "Exhibit A" that is attached hereto and incorporated herein.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that the Public Works Department is authorized to place a Class I legal notice, collect all offers and present all offers on said parcels to the Public Works, Parks and Facilities Committee.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that the Public Works Department is authorized to deposit proceeds from the sale of said parcels into the County Highway Fund of the Public Works Department budget, and to pay from said fund any expenses that may be incurred by and be associated with the sale and conveyance of said parcels.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that any two of the County Clerk, the County Executive and/or the County Board Chairman are authorized to execute any contracts, agreements or other documents necessary to carry out the intent of this resolution.

17 **WHEREAS**, In conjunction with the acquisition of highway right-of-way for the
18 reconstruction of CTH "K" between STH 36 and CTH "S", certain severed remnants of land
19 were acquired with access restriction, near the intersection with Division Road in the Town of
20 Norway; and

22 **WHEREAS**, the Public Works Committee has reviewed these parcels and determined
23 that such property totaling approximately 2.5 acres is no longer necessary for the County's use;

26 **WHEREAS**, Wis. Stats. §83.08(4) (2003-04) authorizes the County Board to sell at
27 public sale such parcels with the funds derived therefrom deposited into the County Highway
28 Fund.
