**RESOLUTION BY THE PUBLIC WORKS, PARKS AND FACILITIES COMMITTEE
AUTHORIZING A CONSTRUCTION PROJECT FOR THE ROBERT L. ROHNER LAW
ENFORCEMENT TRAINING CENTER, AUTHORIZING THE TRANSFER OF FUNDS
WITHIN THE SHERIFF'S DEPARTMENT'S 2005 BUDGET AND AUTHORIZING
CONTRACTS**

To the Honorable Members of the Racine County Board of Supervisors:

BE IT RESOLVED by the Racine County Board of Supervisors that various improvements at the Robert L. Rohner Training Center are authorized and approved pursuant to the following terms and conditions:

1. That the improvements are those previously authorized by Resolution No. 2004-99 which accepted funds for said improvements and Resolution No. 2004-193 which authorized preliminary design and architectural and engineering work for said improvements.
2. That the improvements shall consist generally of:
 - a. A new training center building, furniture and equipment.
 - b. Additional firing positions.
 - c. A two-story range tower.
 - d. A pneumatic turning target system.
 - e. Covered outdoor bleacher-type seating area.
 - f. Covered outdoor weapons cleaning area.
 - g. A shoot house.
3. That the total cost for said project shall not exceed \$1,436,737.61.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that the transfer of funds as set forth in Exhibit "A" which is attached hereto and incorporated herein is authorized and approved.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that any two of the County Clerk, the County Executive and/or the County Executive are authorized to execute any contracts, agreements or other documents necessary to carry out the intent of this resolution.

WHEREAS, Resolution No. 2004-99 authorized an agreement with the Federal Bureau of Investigation to provide funding for the design and construction of alterations and improvements at the Robert L. Rohner Law Enforcement Training Center in the Town of Caledonia; and
