RESOLUTION BY INDIVIDUAL SUPERVISORS AUTHORIZING THE PUBLIC PROTECTION AND JUSTICE SYSTEM COMMITTEE TO CONDUCT A FEASIBILITY STUDY REGARDING THE POSSIBILITY OF PURCHASING THE FORMER DUMORE PROPERTY FOR AN OFF-SITE HUBER FACILITY, MINIMUM SECURITY FACILITY AND/OR DRUG COURT FACILITY

To the Honorable Members of the Racine County Board of Supervisors:

BE IT RESOLVED by the Racine County Board of Supervisors that the Public Protection and Justice System Committee is authorized and directed to conduct a feasibility study regarding the possibility of Racine County purchasing the former Dumore property at 1300 – 17th Street in Racine as a potential acceptable Brownfield location to off-site a 204-bed Huber facility, minimum security facility and/or drug court facility.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that the Public Protection and Justice System Committee is authorized to explore and recommend state and federal grants that would fund "Alternative to Incarceration" programs, building funds, etc.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that the Public Protection and Justice System Committee shall have a full range of authority to completely study and make recommendations regarding the use of the Dumore property by Racine County which shall include, but are not limited to, the following:

1. A minimum security facility that would segregate dangerous criminals from those who pose the least risk.

2. Potential future jail space needs at either the current Wisconsin Avenue location or the possible Dumore property location.

3. Necessary cost or estimates to compare expansion at the current Wisconsin Avenue location to those that would be necessary if the Dumore property was obtained by the County.

4. Other uses for the Dumore property that would accommodate recommendations that have been made by the Criminal Justice Advisory Task Force.

5. A listing of potential state or federal (including private) grants that may support the Committee's recommendations and Racine County's building and program efforts.

6. Potential revenue to Racine County as a result of space available at the current Wisconsin Avenue location as a result of the use of the Dumore site.

7. Any additional recommendations that would help facilitate either expansion of the current jail or that would compliment the County's use of the Dumore property.
