**WHEREAS**, during his tenure on the County Board he served as Chairman of the Court House and Sheriff Committee and the Personnel Committee; he served as Vice-Chairman of the Law Enforcement and Legal Services Committee, and he also served on the Agriculture Committee, County Planning and Civil Defense Committee, Land Use, Agricultural, Environmental, and Extension Education Committee; County Administrator's Committee, Building and Space Needs Committee, Anti-Pollution Ordinance Committee, Ethics Board, and Inspection Team Committee; and

**WHEREAS**, Dennis M. Kornwolf served as County Clerk from 1977 until 1987; and

**WHEREAS**, Dennis M. Kornwolf served as County Executive from 1987 until 1995; and

**WHEREAS**, Dennis M. Kornwolf served as Racine Unified School District School Board Member from 1995 until 1998; and

**WHEREAS**, Dennis M. Kornwolf served as Caledonia Town Board Chairman from 1997 until 2000; and

**WHEREAS**, during his tenure as Assistant Assessor, County Board Supervisor, County Clerk, County Executive, School Board Member, and Caledonia Town Board Chairman, he gained the respect of his colleagues, department heads and his constituents; and

**WHEREAS**, Dennis M. Kornwolf recently passed away.

**NOW, THEREFORE, BE IT RESOLVED**, that the Racine County Board of Supervisors stand and pause for a moment of silence in memory of Dennis M. Kornwolf; and

**BE IT FURTHER RESOLVED** that the County Clerk send a copy of this Resolution to the family of Dennis M. Kornwolf along with the sincere sympathy of the Racine County Board of Supervisors.
