### TERMS AND CONDITIONS

- The initiation and accomplishment of the improvement will be subject to the applicable 1. Federal and State regulations.
- The Municipality will pay to the State all costs incurred by the State in connection with the improvement which exceed Federal/State financing commitments or are ineligible for 2. Federal/State financing.
- Funding of each project phase (preliminary engineering, real estate, construction, and other) is subject to inclusion in an approved program. Federal aid and/or State 3. transportation fund financing will be limited to participation in the costs of the following items as specified in the estimate summary:
  - Preliminary engineering and State review services. a.
  - The grading, base, pavement, and curb and gutter. b.
  - Catch basins and inlets for surface water drainage of the improvement, with C. connections to the storm sewer main.
  - Construction engineering incidental to inspection and supervision of actual d. construction work.
  - Signing and pavement marking, including detour routes. e.
  - Storm sewer mains necessary for the surface water drainage. f.
  - Construction or replacement of sidewalks and surfacing of private driveways. g.
  - New installations or alteration of street lighting and traffic signals or devices. h.
  - Real Estate for the improvement, if required i.
- Work necessary to complete the improvement to be financed entirely by the Municipality or other utility or facility owner or other responsible party (not including the State) 4. includes the following items:
  - New installations of or alteration of sanitary sewers and connections, water, gas, electric, telephone, telegraph, fire or police alarm facilities, parking meters, and a. similar utilities.
  - Damages to abutting property due to change in street or sidewalk widths, grades b. or drainage.
  - Conditioning, if required, and maintenance of detour routes. C.
  - Repair of damages to roads or streets caused by reason of their use in hauling d. materials incidental to the improvement.
  - Bridge width in excess of standards. e.
- As the work progresses, the Municipality will be billed for work completed which is not 5. chargeable to Federal/State funds. Upon completion of the project, a final audit will be made to determine the final division of costs.

- 6. If the Municipality should withdraw from the project, it will reimburse the State for any costs incurred by the State on behalf of the project.
- The work will be administered by the State and may include items not eligible for Federal/State participation.
- 8. The Municipality will at its own cost and expense:
  - a. Maintain all portions of the project that lie within its jurisdiction for such maintenance through statutory requirements, in a manner satisfactory to the State and will make ample provision for such maintenance each year.
  - b. Prohibit angle parking.
  - c. Regulate or prohibit all parking at locations where and when the pavement area usually occupied by parked vehicles will be needed to carry active traffic in the street.
  - Regulate and prohibit parking at all times in the vicinity of the proposed improvements during their construction.
  - e. Assume general responsibility for all public information and public relations for the project and to make fitting announcements to the press and such outlets as would generally alert the affected property owners and the community of the nature, extent, and timing of the project and arrangements for handling traffic within and around the project.
  - f. Provide complete plans, specifications, relocation order, real estate plat, and estimates, except as provided in Paragraph 3 above.
  - g. Use the WisDOT Utility Accommodation Policy unless it adopts a policy which has equal or more restrictive controls.
  - 9. Basis for local participation: 90% Federal; balance by Municipality, as specified in Surface Transportation Program—(H.E.S.) Safety regulations. Of the total project cost estimated at \$1,980,000 for design, real estate and construction, the federal portion of funding is estimated at \$774,000 for State design review and construction. Federal participation shall be limited to \$729,000 for the construction phase of this project. Costs in excess of this amount shall be your responsibility.
