AN ORDINANCE TO AMEND that Certain Ordinance Entitled RACINE COUNTY ZONING ORDINANCE adopted December 2, 1969, found on pages 185 to 232 of the OFFICIAL PROCEEDINGS OF THE RACINE COUNTY BOARD OF SUPERVISORS FOR THE YEAR 1969 as recodified May 28, 1991, by Ordinance 91-196.

The County Board of Supervisors of the County of Racine ordains as follows: Amend the Racine County Zoning Ordinance and change the zoning district for the following described lands from R-2 Suburban Residential District (Unsewered) to B-3 Commercial Service District

PART OF THE Northeast ½ of Section 18, Township 2 North, Range 19 East of the fourth principal meridian, and more particularly described as follows:

THENCE South 89°16' West, 191.29 feet to an iron pipe stake;

THENCE North 50.00 feet to an iron pipe stake;

THENCE South 89°16' West, 279.28 feet to a point in County Highway "P";

THENCE South 19°38' West, along Highway "P", 148.11 feet;

THENCE South 87°47'20" East, 304.25 feet to an iron pipe stake;

THENCE North 89°16' East, 216.29 feet to an iron pipe stake on the East line of Section 18:

THENCE North along the East line of Section 18, 104.48 feet to the place of beginning.

CONTAINING 1.491 acres of land.

SUBJECT TO THE RIGHTS of the public over the West side for highway purposes.

CONTAINING 1.379 acres exclusive of the Westerly 33 feet.
