ORDINANCE BY THE RACINE COUNTY ECONOMIC DEVELOPMENT AND LAND USE PLANNING COMMITTEE TO REZONE FROM B-3 COMMERCIAL SERVICE DISTRICT AND A-3 GENERAL FARMING DISTRICT III TO A-2 GENERAL FARMING AND RESIDENTIAL DISTRICT II

SECTION 1, T4N, R19E, TOWN OF WATERFORD

AN ORDINANCE TO AMEND that Certain Ordinance Entitled RACINE COUNTY ZONING ORDINANCE adopted December 2, 1969, found on pages 185 to 232 of the OFFICIAL PROCEEDINGS OF THE RACINE COUNTY BOARD OF SUPERVISORS FOR THE YEAR 1969 as recodified May 28, 1991, by Ordinance 91-196.

The County Board of Supervisors of the County of Racine ordains as follows: Amend the Racine County Zoning Ordinance and change the zoning district for the following described lands from B-3 Commercial Service District and A-3 General Farming District III to A-2 General Farming and Residential District II

THAT PART OF the Northwest ¼ and Northeast ¼ of the Southeast ¼ of Section 1, Town 4 North, Range 19 East, Town of Waterford, Racine County, Wisconsin, and described as follows:

COMMENCE at the East \(\frac{1}{4} \) of said Section 1;

THENCE S 00°51'47" E along the East line of said Southeast ¼ Section, 662.60 feet to the point of beginning;

THENCE continue S 00°51'47" E along said East line, 662.60 feet;

THENCE S 89°10'40" W along the South line of he Northeast ¼ of said Southeast ¼ Section, 1341,46 feet:

THENCE N 00°48'57" W along the West line of the Northeast ¼ of said Southeast ¼ Section, 564.79 feet;

THENCE S 89°05'53" W, 670.50 feet;

THENCE N 00°47'33" W, 90.68 feet;

THENCE S 88°19'52" W, 200.49 feet;

THENCE N 00°46'08" W, 181.70 feet;

THENCE S 89°15'27" W, 410.00 feet to the East right-of-way line of S.T.H. "164":

THENCE N 00°46'08" W along said East line, 66.00 feet;

THENCE N 89°15'27" E, 1280.72 feet to a point on the west line of the Northeast ¼ of said Southeast ¼ Section;

THENCE S 00°48'57" E along said West line, 234.53 feet;

THENCE N 89°13'03" E, 1340.91 feet to the point of beginning.

The official Racine County Zoning Map is hereby amended to conform to this ordinance.

The Racine County Clerk is directed to transmit duplicate copies of this ordinance by registered mail to the Waterford Town Clerk within seven (7) days after this ordinance is adopted.

NOTE:

The Committee recommended approval of this petition as this rezoning is consistent with the statement of purpose and intent of zoning district as identified in the ordinance; this rezoning is compatible with surrounding zoning and uses; and there are no illegal spot zoning or contract zoning issues.
