**RESOLUTION BY INDIVIDUAL SUPERVISORS AUTHORIZING AN ADVISORY REFERENDUM ON RIDGEWOOD CARE CENTER**

To the Honorable Members of the Racine County Board of Supervisors:

**WHEREAS**, The Racine County Board of Supervisors recognizes Ridgewood Care Center as a vital Racine County resource; and,

**WHEREAS**, The Racine County Board of Supervisors continues to endorse the mission of Ridgewood Care Center; and,

**WHEREAS**, The Racine County Board of Supervisors is deliberating on how to best ensure the continued sustainability of Ridgewood Care Center; and,
