

Modification B to Contract #16-18 A

This contract modification is between RACINE COUNTY HUMAN SERVICES DEPARTMENT (HSD) whose business address is 1717 Taylor Avenue, Racine, Wisconsin 53403 and Provider PROFESSIONAL SERVICES GROUP, whose principal business address is 800 Gould Street, Racine, Wisconsin 53402.

The modification to this agreement will be in effect from July 1, 2016 to December 31, 2016. The Provider agrees to abide by all of the terms of the original agreement dated January 1, 2016 through December 31, 2016 with addition of the following:

**Increase 1531307 ACE/ACE 180 Program by \$18,400, increasing allocation to \$229,400**

**Increase 1531303 Juvenile Monitoring Program by \$20,830, increasing allocation to \$115,050**

**Increase 1531110 Independent Living Program by \$4,600, Increasing allocation to \$58,317**
