Call to Order

Chairman Miller called the meeting to order at 5:04 p.m.

Chairman Comments/Youth In Governance Statement

Ms. Moore read the Youth In Governance Statement.

Citizen Comments

There were no citizen comments.

Approval of Minutes of November 14, 2016 Health and Human Development Committee

Sup. Snow motioned to approve the minutes as submitted. Sup. Dawson seconded.

Alzheimer's and Dementia Presentation

Ms. O'Brien distributed the Alzheimer's and Other Dementia Related Diseases PowerPoint and How the Brain and Body Change Over Time - Alzheimer's Association of Illinois. Ms. O'Brien described Alzheimer's and Dementia. Discussion followed.

Ms. O'Brien listed resources available to patients, patients' families, and the community.

Ms. Goggins explained that a Behavioral Health Services Clinic psychologist does differential diagnosis appointments twice a month. This has helped a lot of people to access appropriate care.

Adult Protective Services staff are being trained in Alzheimer's and Dementia and community wide trainings are being scheduled to support providers.

ADRC staff are trained to provide memory screenings. Individuals sign a release of information so results can be shared with their physicians.

ADRC partners with Alzheimer's Association, Memory Café is their copyright. A Memory Café is an organized socialization for caregivers. One café is currently offered at Old Settlers Bowling Alley in Union Grove.

Human Services Department Division Snapshot

Ms. Otto distributed a draft one page marketing sheet with the Human Services Department's mission statement and core objectives. The mission statement will be enhanced and more concise.

Ms. Otto's objective is to incorporate a marketing team to help better share the good work HSD does. Kimberly Payne and Tim Prust are working on marketing that includes one page program handouts to simplify with user friendly language. Ms. Otto will share the material with members moving forward.

Ms. Otto reported changes within the Division Snapshot Report.

Ms. Goggins reported that the Jail Alternatives program transition is underway. The next step is to work with the Criminal Justice Coordinating Committee, district attorneys, judges, and other stakeholders to determine if the appropriate population is being supervised at the right level of supervision.

Discussion ensued regarding the current SAIL location. The goal is to have things substantially underway by the end of 2017 regarding a future location.

Behavioral Health Services Update

A Mental Health Symposium is scheduled for September 2017. The symposium is a partnership of Racine County, NAMI, and Ascension. Ms. Otto described the symposium, indicated planning is underway and distributed a draft of the flyer, more details to come.

Ridgewood Update

Mr. Doherty reported today's census: 178, Medicaid 108, Medicare 34, and private pay 36.

One nurse manager has been hired, two more need to be hired. An MDS Coordinator has been hired, the former MDS Coordinator promoted to Staff Development and Infection Control and the MDS position was filled simultaneously.

The state has 19 days left for survey.

RESOLUTION BY INDIVIDUAL SUPERVISORS REQUESTING ADEQUATE FUNDING FROM THE STATE AND FEDERAL GOVERNMENT FOR MEDICARE AND MEDICAID REIMBURSEMENT TO SKILLED NURSING FACILITIES

To the Honorable Members of the Racine County Board of Supervisors:

WHEREAS, Care in a nursing home is a vital and necessary service for an important number of citizens throughout Racine County and the entire nation, and,

WHEREAS, Reimbursement for service at all nursing homes for citizens covered by Medicare and Medicaid often does not meet the true costs of those services and,

WHEREAS, Due to inadequate reimbursement from the federal and state government, nursing homes throughout Racine County and the entire nation struggle to provide excellent service to residents at their facilities and,

WHEREAS, Residents needing skilled nursing home services have contributed their lives to building up their communities and over their lifetime have paid taxes for the common good,

NOW THEREFORE BE IT RESOLVED, The Racine County Board of Supervisors respectfully requests that the state and federal government adequately fund skilled nursing facilities for services provided to those citizens who are recipients of Medicare and Medicaid insurance to enable nursing homes of all ownership to provide excellent care for their residents, and,

BE IT FURTHER RESOLVED, The Racine County Board of Supervisors requests that the County Clerk of Racine send copies of this resolution to the President and President-Elect of the United States, our State of Wisconsin Congressional delegation, our State of Wisconsin representatives in Madison, and the Clerks of the counties of Wisconsin.
