RESOLUTION BY THE HEALTH AND HUMAN DEVELOPMENT COMMITTEE AUTHORIZING RACINE COUNTY TO ENTER INTO A LEASE AGREEMENT WITH 2000 LINCOLN CENTER, LLC, FOR THE USE OF BUILDING SPACE FOR THE S.A.I.L. PROGRAM

To the Honorable Members of the Racine County Board of Supervisors:

BE IT RESOLVED that the Racine County Board of Supervisors authorizes and approves an annual lease agreement between Racine County and 2000 Lincoln Center, LLC, for use of building space located at 2000 Domanik Drive, Racine, Wisconsin, for the S.A.I.L. Program under the following terms and conditions:

- 1. The rental space at 2000 Domanik Drive, in the City of Racine, consists of exclusive use of the entire Second Floor for the S.A.I.L. Program; non-exclusive access to the Lunch/Kitchen Room on the Third Floor; exclusive use of approximately nine (9) offices and restrooms on the Fourth Floor of the East Side of the Building in connection with the business of assisting Mental Health Patient; and together with a non-exclusive right to use, subject to reasonable rules and regulations of Landlord, the elevators, walkways, and roadways located on or serving the Property providing access to the Building, as well as the non-exclusive right to use 35 parking stalls.
- 2. The duration of the Lease shall be one (1) year from its effective date with extended terms thereafter.
- 3. The rental agreement shall be:
  - Annual Rent. Annual rent for the Initial Term and for any subsequent extensions, subject to subsection (c), of the Lease shall be \$96,000.00. Of that amount, \$72,000.00 (i.e., \$6,000.00/month) is for Tenant's use of the second floor for the SAIL Program.
  - Payment of Rent. Tenant shall pay to Landlord the annual rent payable in (b) advance in equal monthly installments of one-twelfth (1/12th) of the total yearly rent, which shall be \$8,000.00, on or before the first day of each calendar month hereunder. In addition, Tenant shall pay to Landlord a prorated amount of \$4,000.00 to accommodate an early move-in date of May 15, 2017. Of that amount, \$3,000.00 is for Tenant's early use of the second floor for the SAIL Program.
- 4. Such other terms and conditions as the Corporation Counsel and Human Services Department Director deem necessary and appropriate.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that any two of the County Clerk, the County Executive and/or the County Board Chairman, and the Corporation Counsel where appropriate, are authorized to execute any contracts, agreements or other documents necessary to carry out the intent of this resolution.
