AN ORDINANCE TO AMEND that Certain Ordinance Entitled RACINE COUNTY ZONING ORDINANCE adopted December 2, 1969, found on pages 185 to 232 of the OFFICIAL PROCEEDINGS OF THE RACINE COUNTY BOARD OF SUPERVISORS FOR THE YEAR 1969 as recodified May 28, 1991, by Ordinance 91-196.

The County Board of Supervisors of the County of Racine ordains as follows: Amend the Racine County Zoning Ordinance and change the zoning district for the following described lands from A-1 Farmland Preservation District to A-2 General Farming and Residential District II

LOTS 1, 2 and 3 of CERTIFIED SURVEY MAP NO. 1186, recorded in the Office of the Register of Deeds for Racine County, Wisconsin, on December 9, 1986, in Volume 3 of Certified Survey Maps, Pages 470-471, being a part of the West ½ of the Southwest ¼ of Section 28, Township 4 North, Range 19 East.

EXCEPTING THEREFROM part of Lot 2 of Certified Survey Map. No. 1186, recorded in Volume 3 of Certified Survey Maps, Pages 470-471, Document No. 1213482, being part of the West ½ of the Southwest ¼ of Section 28, Town 4 North, Range 19 East, and described as follows:

COMMENCE at the Southwest corner of said Section 28;

THENCE, N 00 degrees 15'34" E, 715.41 feet along the West line of said ½ Section to the Southwest corner of said Lot 2 of Certified Survey Map No. 1186 and the point of beginning;

THENCE, continue N 00 degrees 15'34" E, 381.45 feet along said West line;

THENCE, N 88 degrees 20'37" E, 376.21 feet along the North line of said Lot 2; **THENCE,** S 00 degrees 15'34" W, 381.45 feet parallel to the West line of said ½

Section; THENCE, S 88 degrees 20'37" W, 376.21 feet along the South line of said Lot 2 to the point of beginning.

RESERVING the West 33 feet thereof for right-of-way purposes.

CONTAINING 3.0036 acres of land excluding right-of-way.

SAID LAND being in the Town of Waterford, Racine County, Wisconsin.

The official Racine County Zoning Map is hereby amended to conform to this ordinance.
