10 **AN ORDINANCE TO AMEND** the Town of Waterford Land Use Map of the
11 document entitled "*SEWRPC Community Assistance Planning Report No. 301, A Multi-*
12 *Jurisdictional Comprehensive Plan for Racine County: 2035*", adopted by the Racine
13 County Board of Supervisors on October 13, 2009, by enactment of Ordinance No.
14 2009-66.

16 **The County Board of Supervisors of the County of Racine ordains as follows:**

18 Amend the Town of Waterford Land Use Map of the "*SEWRPC Community*
19 *Assistance Planning Report No. 301, A Multi-Jurisdictional Comprehensive Plan for*
20 *Racine County: 2035*" to change the land use plan designation of part of parcel
21 identification number 016041928013000, located in part of the Southeast ¼ of Section
22 28, Town 4 North, Range 19 East, in the Town of Waterford, County of Racine, from
23 Extractive (Sand & Gravel Operation) to Commercial as described in Exhibit A,
24 attached hereto.

WHEREAS, a public hearing was held on August 21, 2017, on a proposed amendment to the Town of Waterford Land Use Map of the "*SEWRPC Community Assistance Planning Report No. 301, A Multi-Jurisdictional Comprehensive Plan for Racine County: 2035*" to change the land use plan designation of part of parcel identification number 016041928013000, located in part of the Southeast $\frac{1}{4}$ of Section 28, Town 4 North, Range 19 East, in the Town of Waterford, County of Racine, from Extractive (Sand & Gravel Operation) to Commercial as described in Exhibit A, attached hereto.
