THENCE South 104.00 feet to a point;

THENCE East 175.56 feet to a point;

THENCE North 104.00 feet to the point of beginning, excluding therefrom lands utilized for highway purposes.

SAID LAND being in the Town of Raymond, County of Racine, and State of Wisconsin.
