#6A. - Bev Baker and Jen Reese from UW Extension presented information regarding the new Youth in Governance representatives processes, the recruitment plan handbook, 2018-2019 dates document, the interview questions and interview ratings forms and the group project update.

Bev Baker and Jen Reese presented the application form to be a Youth in Governance Representative. After review it was determined that on page 1 under Health and Human Development "Ridgewood Care Center" will to be removed; page 2 the last notation on the page giving thanks to Washington County should be removed and on page 4 in the shaded FOR OFFICE USE ONLY box parental/guardian signature will be added to the criteria the office checks before processing the application further. The next item reviewed was the Youth in Governance Recruitment Plan, Supervisor's names were assigned to schools listed on the spreadsheet. That Supervisor will be assigned to recruiting and educating that school about the program. That work should begin after the end of the semester in January. UW Extension will contact the Supervisors who were not at the meeting. Next was the Application screening form. No changes were made to the questions the applicants are scored on or the 1-4 rating system. A notation on this form and on the Interview Rating Form will be removed: Note: This form may be shared with applicant. The committee agreed that would not happen with either form so it should be removed. The 2017-2018 Handbook changes were made by the committee are as follows: page 3 under Applicant Recruitment, bullet point 4, removing the last line, "The application includes a written recommendation." under Applicant Nomination, Screening and Selection, bullet point 2, sentence one, remove the words "and recommendations" and replace with "with parent/guardian signature", in the same section bullet point 4.2 all of section 2 will be highlighted. Lastly on page 11 under Health and Human Development "Ridgewood Care Center" will be removed. The Interview Rating Form was discussed and changes made: Two more criteria were added to the rating form; Expressed knowledge of Racine and Overall Presentation. The rating numbers have gone from 1 through 7 to 1 through 10. On the 2018-2019 Schedule handed out one change was made, the date of Tuesday May 22, 2018 as changed to May

Racine County Executive Jonathan Delagrave spoke on the resolution thanking the Chief of Staff and Corporation Counsel for working so diligently with all involved towards this agreement. Consolidation talks started when Burlington experienced the flooding earlier this year. In answer to questions posed by the committee, it was explained that the other municipalities already using Racine County's joint dispatch system must approve the agreement. Contracts went out to all municipalities after discussions and negotiations were complete. Staffing levels will accommodate the addition of Burlington now and services to them will start December 27, 2017. In the future with the arrival of Foxconn, dispatch service staffing and facility must be looked at.

Resolution Number: 2017-09-03

Creating a Nonpartisan Procedure for the Preparation of Legislative and Congressional Redistricting Plans

WHEREAS, currently under the state constitution, the legislature is directed to redistrict legislative districts according to the number of inhabitants at its next session following the decennial federal census by the majority party; and at the same intervals, the legislature also reapportions congressional districts pursuant to federal law; and

WHEREAS, legislative and congressional redistricting plans enacted pursuant to this procedure are used to elect members of the legislature and members of Congress in the fall of the second year following the year of the census; and

WHEREAS, historically legislative and congressional plans in Wisconsin have been viewed by many to be subject to partisan influence; and

WHEREAS, the 2011 process to draw the maps and fight litigation contesting those maps cost taxpayers nearly \$1.9 million; and

WHEREAS, a panel of federal district court judges has ruled that the redistricting that was done in Wisconsin in 2011 was unconstitutional, and that case is now on appeal to the United States Supreme Court, and redistricting to achieve partisan gains is improper, whether it is done by Republicans or Democrats.

NOW, BE IT RESOLVED that the Trempealeau County Board of Supervisors insists upon the creation of a nonpartisan procedure for the preparation of legislative and congressional redistricting plans; and

BE IT FURTHER RESOLVED that the process chosen must promote accountability and transparency and prohibit the consideration of voting patterns, party information, and incumbents' residence information or demographic information in drawing the maps, except as necessary to ensure minority participation as required by the U. S. Constitution, and

BE IT FURTHER RESOLVED that the County Clerk is directed to send a copy of this resolution to the Governor of the State of Wisconsin, the Wisconsin Counties Association, the Wisconsin League of Municipalities, all members of the state legislature, and to each Wisconsin County.
