Budget Priorities Update

Racine County is number one in the State in almost every area of WKRP.

There is an increase in Juvenile Detention Center population.

Assessment Center population is down and that may be attributed to the new philosophy of HALO's transitional shelter.

Thirty-five additional people have started the GED testing process and they could graduate within the year.

Eight students are scheduled to graduate from the 509 Program at the end of this month.

The dip in ACE general population may be because the school year is ending.

Uplift 900

Director Otto described the motivation and background of the Uplift 900 project and what will potentially be asked of the County Board in the coming months.

Mr. Richardson presented the initiative, challenges, and next steps.

Director Otto described a potential limited term project manager position and a taskforce and listed the benefits of both. The position will be presented to the committee in the next weeks to a month.

County Executive Delagrave described the plan for extensive outreach, commented on transportation and other potential barriers to employment that need to be identified and addressed. He also described a potential partner who has had great success with connecting unemployed and underemployed individuals with limited to no skills to sustainability.
