**BACKGROUND**

Racine County Public Works is requesting proposals to provide and install a digital truck scale capable of accurately weighing loaded tri or quad axle dump trucks in excess of 80,000 lbs. at our Rochester Facility 31929 Academy Road, Burlington WI 53105.

Notwithstanding any other provisions of the RFP, Racine County Public Works reserves the right to reject any or all proposals, to waive any irregularity or informality in a proposal, and to accept or reject any item or a combination of items when doing so would be to the advantage of Racine County Public Works.

It is further within the right of Racine County Public Works to reject proposals that do not contain all elements and information requested in this document.

**REQUIRED SERVICES**

The successful vendor will be responsible for the removal of the existing in-ground scale, existing pit, approaches and replace with:

1. New 10' x 40' in-ground NTEP certified 50-ton minimum capacity truck electronic pit type scale. The scale shall be designed as to not interfere with the use of underbody plow blades or wings during winter operations or the towing of trailers onto the scale.
2. Racine County Public Works will excavate new pit to Vendor's size specification. Pit design should include a means to drain water, liquids etc. Racine County will connect to provision at a later date.
3. All metal associated with the scale shall be painted/treated to prevent corrosion.
4. New concrete deck with at least two (2) manhole assemblies
5. New concrete approaches
6. New load cells if required. Load cells are to be connected to instruments compatible with existing Racine County's scale software. Contact Tom Davis @ Advanced Weighing Systems (715-726-0691) to verify compatibility.
7. Scale instruments compatible with existing window mounted remote weight display.
8. Scale shall provide accurate weights to within 20 lbs.
9. Span deflection ratio must be for legal highway loads
10. Vendor is responsible for all electrical installations and the removal/replacement of existing electrical wiring, communication / data wiring.
11. Calibration, testing and scale certification in accordance with Wisconsin Department of Agriculture, Trade and Consumer Protection.
12. Vendors shall specify warranty terms (minimum five (5) years) and type of load cells.
13. Gravel and/or backfill material will be provided by Racine County Public Works.
14. Debris removal from area will be handled by Racine County Public Works
15. Scale will be fully operational, tested and state certified and full accepted by Racine County prior to any payments being made.
16. All work must be completed and accepted within 60 days of contract execution. Late completion shall be subject to a negotiated penalty.
