Juvenile Detention Update – Ed Kamin

Director Otto reported that since Superintendent Kamin's last update, great strides have occurred in both wrap-around care being provided to the delinquency unit and juvenile detention, and the integration of mental health services into detention and Youth and Family programming.

We are presented with a great opportunity to look at major system changes. Director Otto referenced the whitepaper regarding reinventing juvenile corrections that will be presented inlight of Lincoln Hills closing. The State is considering establishing three facilities for southeastern Wisconsin and Racine's cutting edge practices, prevention activities, and robust educational opportunities could position us well to serve as a model for state-wide juvenile corrections transformation.

Mr. Kamin explained the original intent of the whitepaper and said the Governor recently announced Lincoln Hills will close. The Missouri Model, or as Mr. Kamin would like to think of it as the Racine Model, would include the best of what has been done in Racine as well as evidence-based practices from Missouri. Mr. Kamin described the current large prison campus, corrections based setting of Lincoln Hills and highlighted the differences between the Wisconsin correctional facility and the Missouri Model. He further explained that Missouri's outcomes are very positive.

Mr. Kamin reported juvenile detention's challenges and solutions.

Budget Priorities Update – Hope Otto

Director Otto reported highlights for each priority. The new format will be used for 2018.

Sup. Zenner-Richards announced two GED 5.09 classes will graduate in February.

Correspondence and Other Business

Director Otto announced that Brenda Danculovich will assume her new role as Interim Deputy Director tomorrow, January 9, 2018.

Chairwoman Danculovich informed the committee she will resign her HSB chairperson seat and member position. She expressed her pleasure working with the board and committee.
