Increase Business Services by \$21,000 as follows:

Add \$7,000 to 91715.009.600.404500 Business Services Children First, making the total allocation \$18,632.

Add \$7,000 to 91702.009.600.404500 Business Services WIOA Adult, making the total allocation \$20,586.

Add \$7,000 to 91705.009.600.404500 Business Services WIOA-DW, making the total allocation \$26,943.

Increase GED Outreach Coordinator by \$1,500 as follows:

Add \$1,500 to 91704.009.600.404500 GED Outreach Coordinator WIOA OS, making the total allocation \$54,966.


