

Modification B to Contract #17-9







The modification to this agreement will be in effect from October 1, 2017 through September 30, 2018. The Provider agrees to abide by all of the terms of the original agreement dated October 1, 2017 through September 30, 2018 with addition of the following:

Increase LIHEAP Crisis Client Services by \$48,581, resulting in a total allocation of of \$200,606.


