Analysis: Prospective Juror List is representative of the Estimated Population based on the Census information. The Prospective Jury List more closely resembles the Census Information than the Jury Master List. We do see a slightly higher percentage in the 18-24 yrs and 45-44 yrs age ranges in the Prospective Jury list. We also see a 5% higher percentage in White/Caucasian category on the Jury Year Master List but only slightly higher, 3%, on the Prospective Juror List. Our inclusiveness percentage, 90.93%, exceeds the measure/goal.

Analysis: Regular weekly coding of jurors with No Response Follow-up (NRF) and mailings for jurors who did not return questionnaire for the following week appear to be effective. This is resulting in a higher percentage of eligible/available jurors for subsequent service. Ensuring accurate coding of Failure to Appear Follow-up (FTAF) is resulting in a higher percentage of final Failure to Appear (FTA).

Analysis: We have seen a 7% increase in the number of jurors sent to Jury Selection over 2016, however, the number still falls well below the 90% measure and does not meet the goal. We have seen a 1.16% increase, from 2016, in the number of potential jurors selected to serve on a trial. However, the percentage of Jurors called in then selected as jurors falls well below the 30% measure and does not meet the goal. We have seen a 2.42% increase from 2016 in the number of jurors used in Voir Dire. However, the percentage of Jurors used in Voir Dire falls significantly below the 80% measure and does not meet the goal. We have seen a significant 10.6% decrease from 2016 in the number of occasions in which jurors are brought/called in and no trials begin. However, our percentage falls above the 10% measure and does not meet the goal. While we are making small moves in the right directions none of the Measure/Goals have been met. None of the measure/goals have been meet in the last six years.
