1 May 8, 2018 2 **RESOLUTION NO. 2018-11** 3 RESOLUTION BY THE FINANCE AND HUMAN RESOURCES COMMITTEE DECLARING OFFICIAL INTENT TO REIMBURSE EXPENDITURES ON 2018 CAPITAL PROJECTS FROM 4 5 PROCEEDS OF BORROWING 6 To the Honorable Members of the Racine County Board of Supervisors: WHEREAS, Racine County, Wisconsin (the "County") plans to undertake the capital 8 projects listed on Exhibit A (the "Projects"); 9 WHEREAS, the County expects to finance the Projects on a long-term basis by issuing taxexempt bonds or other tax-exempt obligations (collectively, the "Bonds"); 10 11 WHEREAS, because the Bonds will not be issued prior to commencement of the Projects, 12 the County must provide interim financing to cover costs of the Projects incurred prior to receipt of 13 the proceeds of the Bonds; and 14 **WHEREAS**, the County Board of Supervisors of the County deems it to be necessary, 15 desirable, and in the best interests of the County to advance moneys from its funds on hand on an 16 interim basis to pay the costs of the Projects until the Bonds are issued. 17 NOW, THEREFORE, BE IT RESOLVED by the County Board of Supervisors of the County 18 that: 19 Section 1. Expenditure of Funds. The County shall make expenditures as needed from 20 its funds on hand to pay the cost of the Projects until proceeds of the Bonds become available. 21 Section 2. Declaration of Official Intent. The County hereby officially declares its intent 22 under Treas. Reg. Section 1.150-2 to reimburse said expenditures with proceeds of the Bonds, the 23 principal amount of which is not expected to exceed \$6,625,646.00. 24 Section 3. Unavailability of Long-Term Funds. No funds for payment of the Projects 25 from sources other than the Bonds are, or are reasonably expected to be, reserved, allocated on a 26 long-term basis, or otherwise set aside by the County pursuant to its budget or financial policies. 27 Section 4. Public Availability of Official Intent Resolution. The Resolution shall be 28 made available for public inspection at the office of the County Clerk within 30 days after its 29 approval in compliance with applicable State law governing the availability of records of official acts 30 including Subchapter II of Chapter 19, and shall remain available for public inspection until the Bonds are issued. 31 32 Section 5. Effective Date. This Resolution shall be effective upon its adoption and 33 approval.
