12 **AN ORDINANCE TO AMEND** that Certain Ordinance Entitled RACINE COUNTY  
13 ZONING ORDINANCE adopted December 2, 1969, found on pages 185 to 232 of the  
14 **OFFICIAL PROCEEDINGS OF THE RACINE COUNTY BOARD OF SUPERVISORS**  
15 **FOR THE YEAR 1969** as recodified May 28, 1991, by Ordinance 91-196.

17 **The County Board of Supervisors of the County of Racine ordains as follows:**  
18 **Amend the Racine County Zoning Ordinance and change the zoning district for**  
19 **the following described lands from A-3 General Farming District III to A-2**  
20 **General Farming & Residential District II**

21  
22 The East ½ of the East ½ of the Northeast ¼ of Section 10, Township 4 North,  
23 Range 20 East, in the Town of Norway, Racine County, Wisconsin.

24 Excepting therefrom the portion conveyed by deed recorded in Volume 280,  
25 Page 539, as Document No. 376907.

26 Further excepting therefrom that portion conveyed by an instrument dated May  
27 21, 1965 and recorded in Volume 864, Page 110, as Document No. 788509.

28 Containing approximately 39.25 acres, excluding the area currently designated  
29 as A-2 General Farming and Residential District II.

30  
31 The official Racine County Zoning Map is hereby amended to conform to this ordinance.

33 The Racine County Clerk is directed to transmit duplicate copies of this ordinance by  
34 registered mail to the Norway Town Clerk within seven (7) days after this ordinance is  
35 adopted.
