#6a - Racine County Clerk of Circuit Court Sam Christensen will give an overview of his office.

Clerk of Circuit Court Sam Christensen gave an overview of his office. He is an elected, constitutional officer who serves a four-year term. The County Judges would appoint a replacement in the event of a vacancy. His office has full-time, part-time and on-call employees, who handle approximately 48,000 cases per year. They've started sending electronic notices using an eFiling system and text message reminders. They have 23 Court locations which include the Courthouse, Law Enforcement Center, Dennis Kornwolf Service Center/Juvenile Detention Center and Burlington Police Department.

Brian Graziano, Administrative Deputy went over the retention period for record keeping and a summary of jury management. Clerk Christensen mentioned that the difference between their revenues and expenses is not big, so they are not considered to be a money-making office.

Supervisor Roanhouse was excused from the meeting at 6:55 p.m. during the presentation.

The SOTER RS Full Body Scanner is the industry leading contraband detection scanning system which is currently being used in Sheboygan and Kenosha County as well as others in Wisconsin. It is the most clear, concise, and user friendly option, and the Racine County Sheriff's Office is interested in purchasing one for the Racine County Jail. Below are some reasons we are so interested in utilizing this equipment:

- Observe otherwise hidden items in body cavities prior to accepting arrestee into our facility
- Deter criminals from attempting to "hide" drugs, weapons, etc. prior to entering jail; other jails have noticed a significant decrease of criminals attempting to bring drugs into facility through body cavities after installation on body scanner word gets out scanner is in use
- Strengthen security in keeping contraband out of our jail which in turn increases jail safety Process of purchasing to having body scanner in-use is 3-4 months, so we are requesting to purchase this now in hopes of having it in use by end of 2018. Price of body scanner which is \$118,750.00 which includes shipping, installation, calibration and testing, operator and administrator training, 2-year full warranty. Hardware is cost of \$2,139 for computer system. Software is cost of \$2,400.00 annually. Warranty for year 3 and onwards is \$9,750.00 per year.

Initial Cost: \$123,289 = Body Scanner: \$118,750 + Hardware: 2,139 + Software: 2,400


