The Racine County Sheriff's Office was recently notified of the availability of federal funds to enhance the training facility and construct a scenario training building at the Robert Rohner Range.

Additionally, our agency was advised that to obtain funding there are certain criteria that must be met, the following is our understanding of that criteria:

- 1. The County must be able to accept funding related to the project in a timely manner, and place any monies in an account allowing the county to control project related expenditures.
- 2. The account established by the County must be free of restrictions as it relates to expenditure deadlines or monetary amounts.

We are requesting a resolution authorizing the County to accept up to \$300,000 to create a revenue transfer as there is a possibility that additional funds may be made available to Racine County and this would allow the acceptance of additional funds in a timely manner as they are offered.

It is the intent of this Office to provide a detailed report showing all revenues and final expenditures related to any funds received.

Finally, to expedite this project and take advantage of this opportunity, we are respectfully requesting that this matter be considered for  $1^{st}$  and  $2^{nd}$  reading of the County Board.

# Amendment to the Cooperative Agreement for the

# Construction of a Joint Use Firearms Training Facility

This Amendment modifies a Cooperative Agreement dated September 22, 2004, between the Federal Bureau of Investigation (FBI) and the Racine County Sheriff's Office (RCSO) hereinafter referred to as the "parties", to define the scope of work and responsibilities of the parties concerning the use of the Firearms Training Facility (FTF) on property located at 3900 7 Mile Road in the Village of Caledonia, Racine County, Wisconsin. This Amendment consists of two (2) revisions, each numbered separately. For ease of review, affected paragraphs or subsections are reprinted with new language shown in **bold**.

<u>Revision 1:</u> The following paragraph is to be added to section 9 of the agreement, entitled FUTURE FACILITIES:

9 b. FUNDING OF CONSTRUCTION: The FBI hereby agrees to spend a sum of money not to exceed three hundred thousand dollars (\$300,000) for the creation and construction of a scenario training building on the property located at 3900 7 Mile Road in the Village of Caledonia, Racine County, Wisconsin as consideration for and in lieu of the FBI paying for the RCSO a user fee on those days and dates that the FBI will conduct firearms training at the Premises.

The RCSO agrees to pay for those utilities that may be situated upon the Premises at the time that the Premises is used pursuant to this MOU, which are reasonably consumed by the FBI during the FBI's use of the Premises.

The RCSD will secure bids or follow its procurement procedures and provide necessary Contract Administration for the construction of the Scenario Training Building.

The RCSD and the FBI will jointly design and construct a Scenario Training Building.

The design and construction of the Scenario Training Building will be subject to available funding.

Revision 2: The following section is to be added to the end of the agreement:

22. FORCE AND EFFECT: This MOU, to include all amendments that remain in force, is the complete and exclusive statement of agreement between the parties with respect to the construction of a joint Firearms Training Facility on

property located at 39799 7 Mile Road in the Village of Caledonia, Racine County, Wisconsin. This MOU supersedes all written and oral proposals and other communications between the parties. All activities of the parties under this MOU will be carried out in accordance with the terms and conditions of this MOU. Nothing in this MOU is intended to create, nor does it create, an enforceable legal right or private right of action. The foregoing represents the understandings reached between the FBI and the RCSO upon the matters referred to herein.

#### **APPROVALS**

This Amendment consisting of two (2) revisions, taken together with the Agreement dated September 22, 2004, and the Amendment dated August 6, 2015, to which are attached, contains the entire agreement between the parties. It will become effective upon the signatures of all officials listed below, or their authorized representatives.
