Quarry Lake Parking Lot Re-Paving & Reconstruction

GENERAL INFORMATION

The purpose of these specifications is related to Racine County's requirements for purchasing of services to excavate, pave, and restore two parking lots and the road of Quarry Lake Park as described.

REQUIREMENTS

- 1) **Paving:** (Lot 1 80,035 SF) 4 inches of new asphalt shall be paved on freshly new constructed surface in parking lot. (Lot 2 37,651 SF) 2 inches of asphalt shall be overlaid on existing asphalt surface. (Road 10,331 SF) 4 inches of asphalt shall be paved on freshly new constructed surface.
- 2) **Pre-Con Meeting:** There will be a mandatory preconstruction meeting on site prior to the start of the project. A timetable of work shall also be established prior to the start of construction.
- 3) **Staging:** Equipment and materials shall be staged in designated locations on site. Equipment shall be locked up during non-working hours. Materials should be stock piled in such ways that the public will not have easy access (temp fencing, blocking piles with machinery).
- 4) **Excavation:** (Lot 1, and Road) Remove by machinery or other means of pushing/digging approximately 90,366 SF of asphalt, 2,208 CY of unwanted clay base material, and removal of 7 curb islands in parking lot. (Some of the excavation item can be substituted with pulverization in which there would be less unwanted clay base material removal, less asphalt removal, and less base aggregate. Pulverized asphalt millings would take the place of some of the needed base aggregate material.)
- 5) **Trucking:** Trucking, and trucking cost will be the responsibility of the contractor.
- 6) **Restoration:** Restore all planned restoration areas, and disturbed areas with seed, mulch, or erosion mat.
- 7) **Clearing and Grubbing:** All area within the mapped project limits shall be cleared and grubbed (trees, bushes, stumps).

CONTRACTOR'S RESPONSIBILITY

To the fullest extent permitted by law, the Contractor shall indemnify, keep and save harmless the County of Racine, their agents, officials and employees, against all injuries, deaths, loss, damages, claims, suits, liabilities, judgments, costs and expenses, which may arise directly or indirectly from any negligence or from the reckless or willful misconduct of the Contractor or his employees, or of any Subcontractors, or any of their Material Suppliers, or employees and the Contractor shall at his own expense, appear, defend and pay all charges of attorneys and all costs any other expenses arising therefrom or incurred in connection therewith, and, if any judgment shall be rendered against the County of Racine in any such action, the Contractor shall, at his own expense, satisfy and discharge the same.

1. PERFORMANCE AND PAYMENT BOND

- A. The Owner will require the Contractor to furnish a Performance and Payment Bond prior to executing the agreement. This document will be furnished utilizing the latest Wisconsin A.I.A document or the form provided. The total amount will be 100% of the Contract Price. It will be executed by the Contractor as principal and a surety company satisfactory to the Owner.

- B. In the event the Contractor fails to furnish such bonds as required above within ten days from the date of written notice by the Owner, the Owner may, at its sole option, declare the entire contract null and void, notwithstanding any partial performance thereof by the Contractor for the reasonable value of any Work performed by the Contractor prior to such declaration.

- C. Should the surety become irresponsible during the time the contract is in force, the Owner may require additional and sufficient sureties and the Contractor will furnish same to the satisfaction of the Owner within ten days after written notice to do so at no additional cost to the Owner. In default, thereof, the contract may be suspended as hereinafter provided within various portions of the Project Manual.
