Chairman Bernberg called the meeting of the Government Services Committee to order at 4:31 p.m.

#2 – Chairman Bernberg Comments

#4 Cary Madrigal with Racine County Sheriff's department will give an overview of the full body scanner the department is considering purchasing. Committee will take possible action on purchase of equipment.

The reasons for a full body scanner purchase are for increased safety of all involved, jail personnel and inmates, finding secreted weapons, drugs and cell phones. These items not found on current searches will be detected on the SOTER RS scanner. Twenty-seven other areas in the country are using this product. Sheboygan has had it for a year and has had no maintenance problems. The cost of the product will come from the Jail commissary 2018 Budget as well as future warranty costs. Training of personnel is included in the cost of the product, it's done in 4 hour blocks and will be worked around shift schedules. The cost of the two body scanners is \$237,500, Computer Hardware for both is \$4,278 and the Computer Software totals \$4,800 bringing the total for the items to be purchased is \$246,578.00.
