**Section I. Specifications**

**1. Introduction and Objectives:**

The Provider will maintain contracted staff and payroll services for Racine County Human Services located at the Racine County Dennis Kornwolf Service Center in the Youth and Family Division.

**2. Program Description and Requirements:**

**2.1** 4 FTE positions will be staffed by the Provider to include the following:

2.1.1 Foster Home Recruitment and Licensing Specialist – 3 FTE

2.1.2 Kinship Care Specialist – 1 FTE

**2.2** All positions and job descriptions will be approved by Racine County Human Services Department.

**2.3** Paid holidays will coincide with Racine County policy.

**3. Staffing Hours:**

The standard hours are Monday-Friday, 8:00 a.m.-5:00 p.m. However, due to the nature of the work, some evenings, weekends and on-call hours will be required.

**4. Position Qualifications and Essential Duties:**

**4.1 Foster Home Recruitment and Licensing Specialist – 3 FTE**

4.1.1 This position responsible for recruitment of potential foster homes in Racine County, licensing of those homes, re-licensure of existing foster homes, investigation of foster home complaints and concerns and matching/placement of children into appropriate foster homes. This contracted position will work alongside existing county employees in the Human Services Department's Foster Care Recruitment, Licensing & Training Unit.

4.1.2 In order to access the maximum number of potential foster parents, the individual in this position will occasionally work non-traditional hours such as holidays, weekends and evenings. Recruitment efforts at community functions such as the Racine County Fair and Fourth Fest as well as churches and fraternal organizations and clubs will require flexible scheduling. Licensure/re-licensure activity may also require the individual to be available in the early evening to accommodate foster parents' schedules.

**4.1.3 Essential Functions:**

- Recruitment of potential foster parents at assigned community functions.
- Licensure of foster homes for children according to State and Federal standards and HSD policies.
- Processing of referrals from staff and matching of children to available homes
- Problem-solving with foster parents and investigation of licensing violations
- Consultation with referring staff
- Mediation of problem areas between agency staff and foster parents

- Advocacy for foster parents
- Re-evaluation of foster homes prior to license expiration or when there are substantive changes in foster home household; amend or re-license to assure compliance
- Representation of the agency as necessary in court and fair hearings
- Maintenance of foster home records and unit statistics
- Preparation of monthly newsletter
- Representation of HSD at Foster Parent Association meetings
- Interface with the Racine County Marketing Team to create print and electronic marketing pieces.
- Identify, implement and evaluate new sources for Foster Care exposure.
- Maintain up-to-date information on Foster Care website, Facebook page and other social media outlets.
- Take photos of events and record where appropriate.
- Provide support for strategic plan and process.
- For the purpose of recruiting foster families, establish and maintain community contacts such as: Schools, Community organizations; Faith Based organizations; Service groups; Business leaders.
- Use social media to effectively engage the community and create awareness of the need for new foster homes.
- Participate in staff meetings, trainings, workshops and outreach events.
- Perform any other functions as needed by management and agency to meet marketing goals.
- Conceptualize, develop and design materials to effectively achieve desired outcomes.
- Evaluate and measure performance of marketing efforts using metrics and analytics
- Complete tasks and projects within prescribed timeline.
- Flexibility to work evenings & occasional weekends as needed
- Establish a system of assessing the satisfaction of foster families that can be used to identify training, support and treatment needs. Every quarter for licensed foster homes, but monthly for newly licensed foster homes, assess a select number of foster family's needs and strengths to assure training, support and treatment needs are being met for both foster children and foster parents.
- Establish and manage a Racine County Foster Care monthly e-magazine providing foster parents with helpful and supportive information such as recent literature on trauma informed care, networking opportunities with other foster families, support groups, community resources, respite care information and opportunities, changes in foster care rules, recognition of foster families and training opportunities.

4.1.4 **Qualifications:**

- Bachelor's degree in a Human Services field (child development, criminal justice, educational psychology, vocational rehabilitation, guidance and counseling, psychology, social welfare, social work, or sociology).

- Recruitment Staff qualifications may include Bachelor's degree in Communications, Business, Management, Education or a related field. Two (2) years' work experience in making independent decisions and meeting deadlines.
- Valid Wisconsin driver's license

#### **4.2 Kinship Care Specialist – 1 FTE**

4.2.1 This individual will be responsible for approval and review of kinship care homes according to State and Federal standards and HSD policies. This individual will work as a member of the Licensing and Recruitment Unit and will also learn state licensing procedures for foster and for child care certification. Activity may also require the individual to be available in the early evening to accommodate kinship parents' schedules.

##### **4.2.2 Essential Functions:**

- Complete initial walkthroughs, home study assessments, background checks, and all other required paperwork necessary to facilitate a Kinship Care Program placement.
- Document all contact with clients and collaterals.
- Completes announced and unannounced home visits.
- Assists in ensuring the agency meets all federal, state and local kinship care rules and requirements.
- Advocates on behalf of the children in the Kinship Care Program.
- Work collaboratively with RCHSD Youth & Family Division staff.
- Performs all duties in accordance with personnel policies and the program's fiscal guidelines.
- Licensure of level 1 kinship care foster homes for children according to State and Federal standards and HSD policies.
- Re-evaluation of kinship care homes as required by federal, state and local kinship care rules.
- Maintenance of kinship care records.
- Participate in staff meetings, trainings, workshops and outreach events.
- Perform any other functions as needed by management and agency.
- Flexibility to work evenings & occasional weekends as needed.

##### **4.2.3 Qualifications:**

- Bachelor's degree in a Human Services field (child development, criminal justice, educational psychology, vocational rehabilitation, guidance and counseling, psychology, social welfare, social work, or sociology).
- Valid Wisconsin driver's license

#### **5. Employee Recruitment Requirements:**

**7. Outcomes:**

- 7.1 100% of referred candidates will meet minimum qualifications per the job description provided by Racine County.
- 7.2 90% of vacancies will be filled within 60 days of initial posting.
- 7.3 90% of employees will maintain a position within Racine County for the calendar year, maximizing employee retention.

**8. Contract Period:**

Contract will commence January 1, 2019, upon acceptance of the terms described and execution of the contract by both parties. The initial contract period shall continue in effect for one year. Thereafter, it may renew for two additional one year periods at Purchaser's discretion based on Provider performance and funding available.

**9. Cost:**

Cost listed by proposer must be complete and inclusive of all charges at the time of submission. Proposer certifies that prices, terms and conditions in the proposal will be firm for acceptance for a period of ninety (90) days from the date of opening unless otherwise stated by Racine County. Proposal may not be withdrawn before the expiration of ninety (90) days. Prices shall be firm with no escalator clauses unless specified by Racine County. Proposals may be withdrawn after ninety (90) days only upon written notification to Racine County.

**10. Contract:**

The contract for this project will consist of this Request for Proposals document, the specification documents and any associated exhibits or documents, the proposer's response with all required forms, addenda, any negotiated terms and conditions and a standard Racine County contract.

**12. Right of Rejection:**

Racine County, through its duly authorized agents, reserves the right to reject any or all proposals, any portion of a proposal, waive all technicalities, and to accept the proposal considered most advantageous to Racine County following final negotiations, evaluations and reviews. Racine County does not warrant or guarantee that a contract will be awarded as a result of this Request for Proposals.

**13. Instructions to Proposers:**

- 13.1** Thoroughly examine the scope of work, schedule, instructions and all other Solicitation documents and make all investigations necessary to be familiar with conditions that affect the proposal. No pleas of ignorance by the proposer as a result of failure to investigate or examine conditions or failure to fulfill details of the contractual documents will be accepted as a basis for varying the requirements of the County or changing the compensation due.
- 13.2** Racine County contracts are subject to all legal requirements of Racine County, State of Wisconsin or Federal statutes and regulations, as applicable. Laws of the State of Wisconsin apply.
- 13.3** Provide all required information on the forms furnished in this document. Print or type your name and that of your agency on the Proposal Cover Sheet. **Do not include your name or the name of your agency in the body of the proposal!** If you obtained this solicitation electronically, you may complete your responses on the electronic forms however a hardcopy of the proposal must be submitted with your signature on the Proposal Cover Sheet. **15. Contact Person:**

**14.1** The Racine County Human Services Contract and Compliance Monitor will act as the County representative in the issuance and administration of this RFP and contract, and shall issue and receive all documents, notices and correspondence pertaining to this RFP. Such documents, notices, and correspondence not issued by or received by the Contract Compliance Monitor shall be null and void.

**14.2** Questions related to this Request for Proposal shall be delivered in writing (email, postal delivery or hand delivered) to the Contract Compliance Monitor. **Final date**

**for questions is listed in the Calendar of Events.** No questions will be accepted over the phone and no other Racine County representative is authorized to interpret any portion of this RFP.

- 14.3** All questions received by the Contract and Compliance Monitor will be researched and responded to on the date listed in the Calendar of Events and posted on the Racine County Human Services website which can be accessed by the following link:

No verbal or written information, which is obtained other than through this Request for Proposals or its addenda, shall be binding upon Racine County. Proposers are expected to raise any questions, exceptions or additions they have concerning this document as soon as possible during the RFP process.

**16. Confidentiality/Non-Disclosure:**

- 16.1** It is the intent of the County that all proposals received will remain sealed and confidential until reviewed by the Proposal Evaluating Committee.
- 16.2** Once the process is complete, no information submitted as part of this RFP process shall be considered proprietary or confidential.
- 16.3** By submitting a proposal, vendors acknowledge that the County may be required under the law to make its records available for public inspection at any time during this RFP process. All vendors acknowledge and agree that the County will have no obligation or any liability to the vendor if the County must disclose these materials.

**17. Errors or Omissions:**

- 17.1** If a vendor discovers any significant ambiguity, error, conflict, discrepancy, omission or other deficiency in this bid, the vendor should immediately notify the above-named individual of such error and request modification or clarification of the RFP document.
- 17.2** Racine County reserves the right to permit cure of, or waive as an informality, any irregularities or technicalities contained in any proposal submitted, at the sole discretion of Racine County provided such waiver does not substantially change the offer or provide a competitive advantage to any other vendor. Contracts will be awarded in the best interests of Racine County.

**18. Addenda:**

Changes to this RFP will be made only by formal, written addendum issued by Racine County's Contract Compliance Monitor and posted on the Racine County Human Services Website. All addenda issued as part of this RFP shall become part of the specifications of this RFP and will be made part of the contract. It is the vendor's responsibility to check and assure receipt of all addenda.

**19. RFP Evaluation Process:**

- 18.1** Racine County will receive proposals from interested vendors having relevant experience, resources and qualifications in the proposed scope of work. Proposals for this project must contain evidence of the vendor's experience and abilities in the applicable field.

- 18.2** All proposals received will be evaluated by a selection team that consists of Racine County representatives. The team will review and evaluate all detailed proposals submitted and may conduct in-person interviews with proposers if deemed necessary. The selection team will have only the response to this solicitation to review for selection of a finalist. It is therefore important that proposers emphasize specific information considered pertinent to the services provided. Racine County reserves the right to request clarification of any portion of any submittal.
- 18.3** Racine County will be under no requirement to complete the evaluation by any specific date and reserves the right to suspend or postpone the evaluation process should the need arise due to budget constraints, time constraints or other factors as directed by the County. It is anticipated, however, that the review/evaluation process will be completed in a timely manner.
- 18.4** A Proposal Evaluation Committee will be established to review and evaluate all proposals submitted in response to this RFP. The Contract Compliance Monitor will be a non-voting member and, as such, will prepare the proposals for the committee so that no vendor identifying information will be available to the evaluators. The Committee will conduct a preliminary evaluation of all proposals based upon the information provided and other evaluation criteria as set forth in this RFP. The contract will be awarded to the most qualified contractor per the evaluation criteria listed below.

- 18.5** Refer to the accompanying “Program Criteria” document (Appendix E) for specific information to include in your proposal.

**20. Interviews:**

If requested, proposers may be required to participate in an interview at the site of the proposed program or in the offices of the Racine County Human Services Department. Proposers should be prepared to discuss and substantiate any of the areas of the proposal submitted, as well as its qualifications to furnish the specified program. The interviews will be scored by the Evaluation Committee.

**21. RFP Preparation Expense**

Racine County shall not be liable for any expense incurred in replying to any request for proposal or invitation to bid.

**22. County RFP Notice of Rights:**

Racine County reserves the following rights to:

- 22.1** Conduct pre-award discussion and/or pre-award/contract negotiations with any or all responsive and responsible proposers who submit proposals determined to be reasonably acceptable of being selected for award; conduct personal interviews or require presentations of any or all proposers prior to selection; and make investigations of the qualifications of proposers as it deems appropriate, including but not limited to a background investigation conducted by the County or its agents.
- 22.2** Request that proposer(s) modify its proposal to more fully meet the needs of the County or to furnish additional information as the County may reasonably require.
- 22.3** Accord fair and equal treatment with respect to any opportunity for discussions and revisions of proposals. Such revisions may be permitted after submission of proposals and prior to award.
- 22.4** Process the selection of the successful proposer without further discussion.
- 22.5** Request Best and Final Offers from any or all proposers at the sole discretion of the County.

**23. Indemnity and Insurance Requirements:**

- 23.1** Upon execution of a contract, contractor agrees to indemnify, hold harmless and defend Racine County, its officers, agents and employees from all liability including claims, demands, losses, costs, damages and expenses of every kind and description or damage to persons or property arising out of or in connection with or occurring during the course of this agreement where such liability is founded upon or occurring out of the acts or omissions of the contractor, its agents or employees.
- 23.2** Contractor agrees to protect itself and Racine County under the Indemnity Agreement set forth in the above paragraph. Contractor will at all times during the term of this contract keep in force and effect commercial general liability, professional liability, automobile liability, worker's compensation insurance policies issued by a company or companies rated A-VII or better by AM Best and authorized to do business in the State of Wisconsin with the following minimum limits of coverage:
  - 23.3** General Liability
    - 23.3.1 \$1,000,000 each occurrence
    - 23.3.2 \$1,000,000 personal and advertising injury

- 23.3.3 \$1,000,000 general aggregate
- 23.3.4 \$1,000,000 products and completed operations
- 23.3.5 There shall be no exclusion for abuse or molestation
- 23.4 Auto Liability Insurance**
  - 23.4.1 \$1,000,000 Combined Single Limit
- 23.5 Umbrella Liability Insurance on a following form basis**
  - 23.5.1 \$4,000,000 each occurrence
  - 23.5.2 \$4,000,000 aggregate
    - 23.5.2.1 Any combination of underlying coverage and umbrella equaling \$5,000,000 shall be acceptable
    - 23.5.2.2 There shall be no exclusion for abuse or molestation
- 23.6 Workers Compensation Statutory Limits plus:**

- 23.8 Purchaser, acting at its sole option, may waive any and all insurance requirements. Waiver is not effective unless in writing. Such waiver may include or be limited to a reduction in the amount of coverage required above. The extent of waiver shall be determined solely by Purchaser's risk manager taking into account the nature of the work and other factors relevant to Purchaser's exposure, if any, under this agreement.**
- 23.9 Upon execution of a contract and at any other time if requested by Racine County, contractor shall furnish Racine County with written verification of the existence of such insurance.**

**24. Background Checks:**

Upon execution of a contract, contractor will conduct criminal and caregiver background checks through the State of Wisconsin and drug screens on all employees who provide services in this program. Racine County will be provided copies of background check and drug screen results prior to employment. Racine County reserves the right to deny employment in this program when results are deemed unacceptable. Documentation of these background checks and drug screens must be maintained and readily available to Racine County staff.

**25. Audit Requirements:**

In accordance with s.s.46.036 and the purchase of professional services, there is no need for a formal audit. However, in the event that any costs appear to be inconsistent with industry norms, the purchaser reserves the right to request documentation of billed expenses and conduct an Audit Review.
