#1 – Public Comments

Dan McHugh, Assessor of the Village of Mt. Pleasant and Waterford spoke to the committee about businesses requesting reductions on their assessed value. Lawsuits have been filed for that purpose take years to resolve.

#5A New Business

Jerry Deschane from the League of Wisconsin Municipalities will speak to the committee discussing dark stores.

The concern of the League is a tax shift from large properties to residential properties and small businesses at an average of about 8%. Dark Stores are big box stores which have no comparable properties, if they were to leave the property it could only be valued as an empty building. There are two bi-partisan bills in the legislature supported by about 80 legislators; one would allow only open stores to be compared to open stores for assessment purposes and the second would allow above market lease income to be used for assessment purposes. Attorneys work on a percentage of recovery payment meaning there is no cost to those who file for assessment appeals.

#5B. New Business

<u>Cory Fish, Directory of Tax, Transportation and Legal Affairs of the Wisconsin Manufacturers & Commerce</u> (WMC) will speak to the committee discussing dark stores.

The WMC believes that business income should not be taxed as property and the rule of taxation should be uniform. The above market leases are used to expand businesses and are a really a loan being paid back with interest. It was pointed out the levy limit may be repealed in the future meaning it will be harder to appeal tax assessments. The use of vacant rundown properties was thrown out as comparable but WMC believes if a vacant property is truly comparable it should be allowed as an assessment tool.

Both representatives received and answered questions from the committee members.

Michigan has rejected the Dark Store theory and 6 other states are looking at litigation.

Both organizations share the goal of growing the state in population and jobs, where they disagree is tax law.
