Call to Order

Chairman Maier called the meeting to order at 5:02 p.m.

Chairman Comments/Youth In Governance Statement

Resolution In Support of Increased Funding and Oversight Reforms for Wisconsin's Child Protective Services System

Director Otto explained the purpose for the resolution.

Sup. Miller moved to approve. Sup. Trottier seconded.

Sup. Miller suggested that Director Otto or someone be at the County Board meeting to provide a summary.

Sup. Miller also asked that area legislators be substituted with all legislators, line 30, page 2.

Sup. Trottier asked what the current allocation is across the state and how much Racine is requesting, the increase of what amount? Director Otto said it's approximately a 70% increase, she will find out the exact amount and report back.

Motion carried.

Aging and Disability Resource Center Program Updates

Director Otto introduced Amy O'Brien, ADRC Director and Katy Hansen, Aging Director.

Ms. O'Brien distributed a PowerPoint, ADRC's Fall 2018 Newsletter and a general ADRC brochure. She explained there are several divisions co-located with the ADRC. Ms. O'Brien provided an overview of ADRC services.

Ms. Hansen provided an overview of aging services, care giver assistance, support groups, outreach services, classes, Adult Protective Services, and the senior nutrition program/Meals on Wheels.

Sup. Buske commended Ms. O'Brien and Ms. Hansen for the great job ADRC is doing.

Discussion ensued.

Budget Priorities Update and Establish 2019 Budget Priorities

Director Otto reported highlights of the 2018 report, suggested changes for the 2019 Budget Priorities and provided an overview of each change. Members agreed with the 2019 changes and suggested additional changes. Director Otto will update the 2019 Budget Priorities to reflect all changes and report back requested information at the next meeting. An opioid presentation will be on the next agenda.

Correspondence and Other Business

Director Otto explained that Workforce Solutions is looking at identifying how it can support local businesses and our community with getting opportunities for the jobs that will open because of Foxconn, subsequent supply chain, and development. In a preliminary look at Manpower's study and what gaps need to be filled, particularly in healthcare, it's been determined Racine County wouldn't make a dent in the numbers needed to support the growth.

Director Otto would like to submit a proposal, money is already identified from the County Executive's budget to support the next phase of the study. She asked the committee what the next steps are and what she needs to do to take it as a resolution to Finance or to this committee. She'd like to have it done by the end of the year.

RCEDC did the first study utilizing Racine County's Revolving Loan Fund (RLF) and Director Otto is requesting to move to step two. Sup. Miller said to ask Chairman Clark what committee if any he wants it to go to.

Director Otto may need to call a special committee meeting if advised by Chairman Maier and the committee.

Discussion ensued and it was decided that a special committee meeting may be scheduled and Director Otto will request first and second reading at the next County Board Meeting. The dates would be October 25 HHD Committee and November 5 Finance, Director Otto will speak with Chairman Clark and keep everyone informed.

Chairman Maier thanked Workforce Solutions for inviting him to the NAACP Dinner.
