Call to Order

Chairman Maier called the meeting to order at 5:00 p.m.

Chairman Comments/Youth In Governance Statement

Ms. Brown read the Youth In Governance Statement.

Public Comment Period Not to Exceed Fifteen (15) Minutes (Each Speaker Shall Be Allotted a Maximum of Three (3) Minutes). The Speaker Shall Speak on Any Topic.

Kenneth Kurt introduced himself as a facilitator of Smart Recovery. He is a certified therapist who practiced medicine for 50 years. Mr. Kurt cited sobering overdose statistics in this community adding that most substance abuse starts at ages 12-14. He announced an upcoming open meeting on November 14, 2018 at 10 am at the Ives Grove complex where he hopes to bring together members of the educational and law enforcement communities to discuss strategies for addressing this issue. County Executive Delagrave offered to announce the meeting at the full County Board later this evening.

Chairman Maier noted that the October 25 meeting minutes, on page one of three, in regards to the Resolution Authorizing the Acceptance of Youth Justice Innovation Grant from the Wisconsin Department of Children and Families in the Amount of \$250,000.00 the committee was advised by Mr. Lanzdorf that the first reading would be November 5 and that resolution did go to County Board that night for first read and first reading only.

Resolution by the Health and Human Development Committee Authorizing the Acceptance of a Wisconsin Fast Forward Grant from the Wisconsin Department of Workforce Development and Authorize Multi-Year Contracts with the Training and Outreach Providers

Director Otto explained that this grant has been worked on for six or seven months. They're in the acceptance stage of the grant and ready to move into the recruitment and training phase of the grant. The Community Connectors grant to portion of the grant has also been awarded to the WRTP. This resolution is to accept the grant of \$314,000. This will go to County Board for first reading tonight.

Resolution by the Health and Human Development Committee Authorizing the Application and Acceptance of Brighter Futures Initiative Grant from the Wisconsin Department of Children and Families in the Amount of \$208,670.00 and Authorization of a Multi-Year Contract with Focus on Community

Director Otto explained that HSD received a grant for \$208,670.00 to do community-based prevention work, earlier intervention targeting children in 6th and 7th grades. Expanding on the existing Life Skills Program done by Focus on Community. The three focal points are personal self-management skills, general social skills, and job retention skills.

Opioid Treatment

Ms. Goggins introduced Kevin Lunog, Clinic Director, and Pauline Outloff, AODA Program Supervisor.

Ms. Goggins distributed and presented Opioids in Wisconsin and Racine County PowerPoint.

County Executive Delagrave said Racine County participated in the lawsuit with regards to drug companies, we're on the front of that to make sure they are held accountable.

Behavioral Health Services is partnering with the Sheriff's Department and the Racine Police Department to look at how we can get information out through law enforcement that are diversion related. Connect people to treatment options as opposed to arrest.

County Executive Delagrave said that he, Ms. Goggins, the Sheriff, the district attorney, doctors from Aurora and Ascension have had proactive assemblies in schools to provide education and resources.

Discussion ensued.

Senior Manager of Talent Acquisition/Deputy Position

Director Otto announced that an offer was extended to Kristin Latus and she has accepted to lead our regional Talent Attraction and Recruitment Strategy. The duration of the project being potentially a few years assume into the full functions of Deputy Directory. She will start December 3, 2018.
