DATE:

We are requesting to amend the 2019 Racine County Capital Budget so that we may order and install traffic signals at the intersections of CTH V & C and CTH V & G.

The cost to purchase and install traffic signals is approximately \$83,000 per intersection. We would ask to create a new capital project for these signals and allocate \$200,000 for that account in case there are any unforeseen extra charges incurred.

We would also ask to reduce the amount of capital for 2019 in the line item "U" box culvert ½ Mile north of CTH G by \$200,000. This will allow \$200,000 to remain in that capital project and allow \$200,000 for signals purchase and installation.

The intersections of CTH V/C and V/G have seen significant backups and increases in accidents, due to development around I-94, road construction and various closures. Staff has spoken with DOT officials, as well as the PWPF Committee and local officials and we have received their concurrence that signals are needed at these two intersections. One south shore fire official recently stated that the signals are needed at CTH C/V "yesterday" due to the amount and severity of crashes in this intersection.

The signals will have two extra features installed. One feature is known as EVP or Emergency Vehicle Pre-emption. This system allows emergency vehicles to get through an intersection quicker and more safely. The second feature is known as VVDS or Vehicular Video Detection System. This system helps address backups and allows more time for specific traffic movements. The system makes real-time adjustments to help clear out backups more quickly.

We anticipate additional changes with the intersection of CTH V/C as two new hospital campuses are built in the near vicinity as well as other development that is planned in this area.

Thank you for your consideration of this requested budget amendment.

#### Mr. Behm,

Thank you for the opportunity to provide pricing on this work. Per our telephone conversations, our scope will include installing temporary traffic signals at the intersection of CTH V & CTH C. These "temporaries" may end up being installed for several years, until new intersection improvements are done which would include a new signal installation. We are providing prices to furnish & install used equipment like a Traditional temporary traffic signal installation and also new equipment which could be Transferrable into a new intersection.

The following pricing reflects Racine County taking ownership of the equipment once the intersection is turned on. Specifications for the future permanent installation can be written such that all temporary equipment either be used in the new intersection or returned back to the County for use on future jobs or maintenance. We would be available to perform maintenance and repairs on the installation on a T&M basis for as long as needed.

Our temporary equipment will meet WisDOT Standard Specifications and include the following:



Lump sum cost to furnish and install the above equipment: \$51,700.00 LS

Utilizing Type 1 and 2 signal standards in this Transferrable scenario will provide a more uniform, consistent look for drivers. Installing the Type 1 poles on the chance bases will be easier to install than concrete footings and could be easily moved in the future if necessary. I propose installing a Type 2 pole with a trombone arm along with a Type 2 concrete base on the SW corner since it's a wider corner. An overhead signal mounted on a trombone arm would be easier for SB drivers to see.

#### Options:

<u>Vehicular Video Detection System (VVDS)</u>: Having video detection will help in addressing backups and allowing more time for specific movements. The system will make real-time adjustments to help clear out backups quicker. Please add the following to our quote to furnish and install:

Traditional: \$16,600.00 LS Transferrable: \$22,300.00 LS

Emergency Vehicle Preemption (EVP): You would know better if emergency vehicles use this intersection enough to warrant an EVP system. EVP systems help allow emergency vehicles get thru the intersection quicker and more safely. Please add the following to our quote for us to furnish and install:

Traditional: \$7,200.00 LS Transferrable: \$8,900.00 LS

The Intersection has numerous overhead wires which will conflict with a conventional overhead temporary installation where all of the signal heads are installed on the overhead lines. We propose installing only conductor wire spans overhead across the roadways. Please see the attached sketches for our proposed layouts. The first layout is for utilizing used, more Traditional temporary equipment. The second layout is for using equipment that could be Transferrable to a new installation.

Since there are lanes that share a thru and left turn movement, we have included some 4-section heads: R, Y, G, Green arrow. This might be a good solution for the NB direction that gets backed up as a result of the 194 congestion. This signal head would allow traffic in the NB direction to clear out quicker by being able to turn left, go straight, or turn right while all other directions have a red. You might want to run your traffic volume scenarios thru a traffic signal designer to optimize movements, layout, timings, etc. Installing, adjusting or modifying layout or timings to be done on a T&M basis.

The electrical service installation costs from WE Energies is to be paid by Racine County. We will install a meter socket, submit an affidavit, and coordinate with We Energies for the installation of the new service.

Simple traffic control is included in the above pricing. Erosion control, Signing and Pavement marking are by others.

Please call if you have any questions. I would be happy to review these scenarios further as well as any other ideas you might have.


