BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that the transfer of funds as set forth in Exhibit "A," that is attached hereto, within the Sheriff's Metro Drug – State 2019 Budget and the purchase of \$10,031.00 worth of surveillance equipment is authorized and approved.
