RESOLUTION BY THE PUBLIC WORKS, PARKS AND FACILITIES COMMITTEE TO OPT OUT OF IOH (IMPLEMENTS OF HUSBANDRY) REGULATIONS REGARDING LENGTH AND WEIGHT LIMITS FOR AGRICULTURAL IMPLEMENTS AND AGRICULTURAL COMMERCIAL VEHICLES ON RACINE COUNTY AND STATE HIGHWAYS AS AUTHORIZED BY WISCONSIN ACT 377

To the Honorable members of the Racine County Board of Supervisors:

WHEREAS, 2013 Wis. Act 377, under Sec. 348.27(19)(b)5.a., provides that a municipality or county may authorize implements of husbandry as defined in Sec. 340.01 (24) and agricultural commercial vehicles as defined in Sec. 340.01(10) of the Wis. Statutes to exceed any statutory length and weight limits imposed by Chapter 348 of the Wis. Statutes.

**NOW, THEREFORE, BE IT RESOLVED** by the Racine County Board of Supervisors that pursuant to Sec. 348.27(19)(b)5.a. of the Wis. Statutes, implements of husbandry and agricultural commercial vehicles defined by Chapter 340 of the Wis. Statutes may exceed any length and weight limits imposed by Chapter 348 of the Wis. Statutes, subject to seasonal and special postings.

**BE IT FURTHER RESOLVED** by the Racine County Board of Supervisors that this resolution shall remain in effect until rescinded by further action of the board.

**BE IT FURTHER RESOLVED** by the Racine County Board of Supervisors that the Racine County Clerk transmit a copy of this resolution within seven (7) days after this resolution is adopted to the Wisconsin Department of Transportation, PO Box 7980, Madison, WI 53707-7980 (AgVehicles@dot.wi.gov) to be posted on the WisDOT website.
