Reasonable administrative funds may be withdrawn from the RLF to cover personnel costs and other administrative expenses. Local funds may b used in situations when loan repayments are insufficient to cover administrative costs. Effective January 1, 2014, Administrative expenses up to twenty (20) percent of program income as defined by the Wisconsin Department of Administration may be used for direct loan administrative costs.
