AN ORDINANCE TO AMEND that Certain Ordinance Entitled RACINE COUNTY ZONING ORDINANCE adopted December 2, 1969, found on pages 185 to 232 of the OFFICIAL PROCEEDINGS OF THE RACINE COUNTY BOARD OF SUPERVISORS FOR THE YEAR 1969 as recodified May 28, 1991, by Ordinance 91-196.

The County Board of Supervisors of the County of Racine ordains as follows: Amend the Racine County Zoning Ordinance and change the zoning district for the following described lands from A-3 General Farming District III to A-2 General Farming and Residential District II

PART OF the Southwest ¼ of the Northeast ¼ of Section 2, Township 4 North, Range 19 East of the 4th principal meridian, Township of Waterford, County of Racine, Sate of Wisconsin, and more particularly described as follows:

COMMENCE at the center of said Section 2:

THENCE North 01°01'24" West along the West line of said Northeast ¼ Section, 661.09 feet:

THENCE North 87°47'16" East 35.50 feet to the place of beginning of this description;

THENCE North 04°08'50" West 651.27 feet to a point on the North line of the South ½ of the Northeast ¼ of said Section 2;

THENCE North 87°38'24" East along said North line 1337.35 feet to a point in the center line of Halvorson Road;

THENCE South 00°54'46" East along said center line 674.77 feet;

THENCE South 87°54'24" West 1177.86 feet;

THENCE North 01°44'04" West 17.80 feet;

THENCE South 87°47'16" West 122.34 feet to place of beginning.

The official Racine County Zoning Map is hereby amended to conform to this ordinance.

The Racine County Clerk is directed to transmit duplicate copies of this ordinance by registered mail to the Waterford Town Clerk within seven (7) days after this ordinance is adopted.
