Discuss Public Hearing Comments

There were no comments to discuss.

Review 2020 Budget Planning Paper

Director Otto provided an overview of how the budget is developed and the planning process. The HSD and BHS budgets may be combined in the future.

Director Otto presented the 2020 Budget Planning Paper.

Following a discussion about next year's anticipated challenges, Director Otto informed the committee that she is presenting tomorrow about applying to repurpose revolving loan fund dollars to use for the Community Development Block Grant program (CDBG).

Discussion ensued regarding internship programs within the County in addition to internships already being offered in a few departments. The County's budget will include six paid internships in several departments and the goal is employment with the County.

Correspondence and Other Business

Director Otto referenced her earlier comment about the presentation to the Executive Committee tomorrow about repurposing the CDBG dollars to use for new workforce programming. The amount that will be requested is \$2M over two years or an additional \$1M per year. The goal is to get 200 placements in two years with actual employer commitments. The first anticipated targeted placement is with Advocate Aurora in high demand positions with the starting wage at minimum \$14 per hour and by 2021 the wage will be \$15 an hour, closer to family sustaining wages. This is a great segue for pathways to success. The targeted areas are customer service, hospitality, food service, CNA, phlebotomy, and medical assistance. Advocate Aurora has already identified twelve positions as the first pilot project. The hope is for support from the County Board and the Executive Committee to engage in repurposing those dollars to help support the pilot.

A public hearing will have to be held because it involves federal dollars and public input and support is needed to utilize CDBG funding. Director Otto will ask the Health and Human Development Committee to meet the second date of the month in August to hold the public hearing; that date will be August 26th. Director Otto will reach out to board members to serve in an advisory capacity. The DOA has recommended we utilize existing board members, so it runs more seamlessly.
