We are excited to share our journey toward more impactful, collaborative services to eliminate barriers and empower communities.





#### **Building Bridges**

In the words of Uplift 900 Manager, Pastor Melvin Hargrove, we must get serious about reconnecting with communities and bridging gaps in opportunities and quality of life for all residents. That is why we launched two new initiatives in 2018: Uplift 900 and Bring Them Home. The former takes work-ready resources, training, and family-sustaining jobs directly to high-unemployment communities. The latter recruits local foster parents and keeps children with their families or in the community.



#### Eliminating Barriers

Our department is committed to meeting head-on barriers faced by individuals with Adverse Childhood Experiences (ACE) or trauma, second-chance residents, the underemployed and unemployed, individuals with mental-health and substance-abuse challenges, and underserved communities. This year, we supported residents at high risk of contact with law enforcement, brought resources such as records expungement and driver's license recovery to community events, and trained dozens of partners in trauma-informed care.



#### **Empowering Communities**

Residents thrive when opportunities ensure success beyond a single service or resource. In 2018, we proudly raised awareness around resources for caretakers and the growing population with dementia, offered mental-health services to people involved in the justice system, provided critical services such as medical and nutrition assistance to thousands of residents, and funded hundreds of free training opportunities in high-demand, high-wage jobs.






# BEHAVIORAL HEALTH SERVICES

Providing mental health and substance use disorder services to Racine County residents





#### Expanding Services for Expanding Need

Research indicates individuals taking medication to assist in their recovery are more likely to be successful. As a result, Behavioral Health Services began conducting outreach to individuals with opioid addiction to encourage medication-assisted treatment.

Behavioral Health Services also developed a screening process, substance use assessments, and same-day appointments to expand access to counseling for residents in need. These efforts drastically increased the total number of individuals served over the last five years.

#### THC Alternative Solution





# WORKFORCE SOLUTIONS

#### Building a skilled workforce through community and collaboration

Racine County Workforce Solutions partnered with dozens of community and workforce organizations to build a community-wide workforce plan, fully fund short-term trainings for hundreds of residents, and provide critical employment supports to the unemployed and underemployed, incarcerated, ex-offenders, and out-of-school youth.



## Building the Workforce of Racine County

Racine County partnered with Racine County Economic Development Corporation (RCEDC) and ManpowerGroup to build a comprehensive plan to address the growing demand for talent. After facilitating discussions with dozens of business and community leaders, Racine County developed strategies and goals to attract, develop, retain, and grow our future workforce across the fastest growing jobs families.

## Upskilling the Incarcerated and Ex-Offenders

Windows to Work promotes self-sufficiency for individuals returning to the community after incarceration. In 2018, Racine County in partnership with the Department of Corrections helped 30 individuals develop work-readiness skills, connect with community resources, and gain employment. Short-term, free trainings in mechanical maintenance and repair technician were also provided through a Department of Workforce Development grant with Gateway Technical College instruction.

## Providing High-Tech Training

Racine County, Twin Disc, and Leeward Business Advisors led efforts to create StartIT, an innovative technology program offering paid work experience and certifications to underserved, out-of-school youth. Racine County also partnered with the Southeast Wisconsin and Waukesha-Ozaukee-Washington Workforce Development Boards to fund IT training for over 30 residents.

The City of Racine has faced the highest unemployment rate in the State of Wisconsin for over a quarter century.

Uplift 900 is a new initiative to engage, empower, and employ 900 unemployed City of Racine residents and in theory, close the gap between the city and state unemployment rates.

To help employ 900 Racine residents, Uplift 900 brings local resources such as records expungement, driver's license recovery, and training directly to communities in need.




#### **Untapped Potential**


Over 20,000 City of Racine residents face educational barriers to high-skill, high-wage employment. This is roughly two in every five City of Racine adult residents over age 25.

Racine County Workforce Solutions and Higher Expectations partnered with UW-Parkside to conduct a labor market analysis of local drivers of unemployment. The study found high school diploma and bachelor's degree attainment as well as parental status are significant drivers of employment.

Educating unemployed and underemployed residents will become increasingly important to meet growing demand for skilled talent.

# JUVENILE DETENTION

Helping youth learn positive, effective ways to solve problems and resolve conflicts

Racine County Juvenile Detention provides education, medical, and mental health therapy services to address life challenges positively, avoid the Adult Correctional System, and become productive members of society. Below are services offered to youth in Alternatives to Corrections through Education (ACE):



#### Interactive Journaling

Interactive Journaling is youthcentered, self-driven change, addressing topics such as "What got you here?", healthy relationships, and individual change plans.



#### Mind Up

Mind Up is a research-based curriculum offering easy strategies to focus attention, build stress resilience, and develop a positive mindset in school and life



#### Aggression Replacement Therapy

Aggression Replacement Therapy is a cognitive behavioral program featuring social skills training, anger control, and moral reasoning to reduce aggression in youth.



#### Carey Guides

Carey Guides are evidencebased tools to help youth work on identified need areas.

#### About Us

Youth and Family aims to keep children safe, families healthy, and build a better community. Each staff member works with families to create long-term, sustainable change so children and families can function together.

Foster Child Re-Entry Rate into Out-of-Home Care by County

Racine 9.3 Milwaukee 17.5 Kenosha Waukesha 22.7 Dane

Foster child re-entry rate is how much time, if any, elapses before children who have been reunified are re-removed from their family due to new allegations of abuse or neglect.

Racine, one of the 9 largest counties in Wisconsin, has the lowest re-entry rate and is the only county to meet the federal threshold with a re-entry rate below 10%.

#### New Program: Safety Support

100% of families had no reported findings of additional maltreatment on open cases. 85% of family cases were closed with the child identified as safe.





# Featured Initiative **BRING THEM**

A Racine County Foster Care Movement

The Racine County Foster Care Program launched a new campaign to help keep Racine County foster children in the community.

The Bring Them Home campaign has two central goals: to recruit and license new foster homes in Racine County and bring back local children who were placed in homes outside the county. The campaign comes as the county has experienced a foster care crisis, seeing both a rise in the number of children placed in foster care and a decline in local foster homes.

Keeping foster children in the community allows siblings to stay together and potentially shortens the length of time children are in out-of-home care. Separating siblings deepens the trauma

facing foster children, who are already forced away from their family home.

The Bring Them Home campaign is a rebranding of the county's foster care work. The effort includes a social media blitz, videos, grassroots outreach, advertising, and much more. Racine County Foster Care also worked with filmmaker Joey Papa, who previously produced a short film, (Un)wanted, about the local foster care crisis.
