**RESOLUTION NO. 2019-61** 

RESOLUTION BY THE FINANCE AND HUMAN RESOURCES COMMITTEE **AUTHORIZING FOUR MILLION FIVE HUNDRED SEVENTY THOUSAND AND 00/100** (\$4,570,000.00) IN ADDITIONAL FUNDING FOR CTH KR COSTS INCLUDING ACQUISITION, COMPENSABLE UTILITY **PROPERTY** MOVES, AND PROFESSIONAL CONSULTANTS AND TRANSFER OF FUNDS WITHIN THE 2019 HIGHWAY CAPITAL PROJECTS BUDGET

To the Honorable members of the Racine County Board of Supervisors:

WHEREAS, the function of Racine County is to promote the health, safety, and general welfare of County residents; and

WHEREAS, the Racine County Board of Supervisors has authorized the limited jurisdictional transfer of a portion of County Highway KR ("CTH KR") to the Wisconsin Department of Transportation for development and implementation of roadway improvements with Resolution No. 2017-60 and 2017-124; and

**WHEREAS**, that jurisdictional transfer agreement requires, among other things, that Racine County shall be responsible for the cost of compensable utility moves and for acquiring all needed right-of-way within Racine County; and

WHEREAS, by Resolution 2018-137 and Resolution 2019-47, the Racine County Board of Supervisors has approved upgrading and expanding a portion of CTH KR, which is in need of improvement for future usage and has approved a Relocation Order and Plat setting forth required property interests therefor; and

**WHEREAS**, a portion of the anticipated CTH KR-related costs (e.g., ROW/property acquisitions and utility expenses) - in the amount of One Million Two Hundred Fifty Thousand and 00/100 dollars(\$1,250,000.00) - was included in the Racine County 2019 Budget with the remaining land acquisition costs then expected based upon initial estimates provided by the Wisconsin Department of Transportation to be included in the Racine County 2020 Budget; and

WHEREAS, in order to keep the CTH KR project on schedule and minimize costs and disruption to impacted residents, it is necessary to complete the acquisition of certain priority parcels prior to authorization and implementation of the Racine County 2020 Budget to meet the Wisconsin Department of Transportation's timeline for letting necessary utility work in January 2020; and

WHEREAS, based upon budget projections for necessary land acquisition provided by the team of land acquisition consultants, an additional approximately Four Million Five Hundred Seventy Thousand and 00/100 dollars (\$4,570,000) - with approximately Two Million Eight Hundred Fifty Thousand and 00/100 dollars (\$2,850,000.00) of that projected amount needed to fund acquisition of priority utility parcels in 2019 – is needed to complete necessary land acquisition and compensable utility moves for the CTH KR project; and
