1 2 **RESOLUTION NO. 2019-73** 3 4 RESOLUTION BY INDIVIDUAL SUPERVISORS AUTHORIZING DISCONTINUATION 5 OF ALL COUNTY HEALTH INSURANCE FOR ACTIVE COUNTY BOARD 6 **SUPERVISORS EFFECTIVE APRIL 14, 2020** 7 8 To the Honorable Members of the Racine County Board of Supervisors: 9 10 WHEREAS, pursuant to Resolution 2011-68 and Resolution 2012-90, County health care coverage remains available only to those elected county board supervisors 11 12 who held such office on December 31, 2011; and 13 WHEREAS, Wisconsin Stat. § 59.10(1)(c) vests broad discretion in county 14 boards of supervisors in self-organized counties to determine how supervisors in such 15 counties will be compensated; and 16 **WHEREAS**, the current two-year term of office of supervisors ends at 11:59 p.m. 17 on April 13, 2020; and 18 **WHEREAS**, no other part-time County employees – other than elected County 19 board supervisors who held such office on December 31, 2011 – are entitled to County 20 health care coverage and the Racine County Board of Supervisors wishes to take action 21 toward elimination of all County health insurance for active County Board Supervisors 22 effective April 14, 2020. 23 NOW THEREFORE BE IT RESOLVED by the Racine County Board of Supervisors that, effective April 14, 2020, County health insurance shall no longer be 24 25 available to active County Board Supervisors regardless of the length of time in elective 26 office. 27 BE IT FURTHER RESOLVED that, notwithstanding any previous resolutions of 28 the County Board of Supervisors concerning health care coverage, the Racine County 29 Board of Supervisors considers such resolutions to be superseded, effective April 14, 30 2020, to the extent that they are inconsistent with the provisions of this resolution. 31 Respectfully submitted, 32 33 1st Reading INDIVIDUAL SUPERVISORS 34 35 2nd Reading 36 37 **BOARD ACTION** 38 Adopted 39 For 40 Against 41
