Supervisor Osterman gave an update and stated this program had been implemented a couple of years ago and Racine County was one of several counties that were part of the program. He gave an explanation regarding the process for submitting a project to the group. This property was Racine County's first to use the PACE program for financing.

#### #7 – Resilient Communities Update.

County Executive Delagrave said that a couple of year ago, the Johnson Foundation at Wingspread had collaborated with the municipalities east of I-94 to facilities conducting studies about various ways to combine or improve operations in the region. An informational briefing for the group was being scheduled in November to share those results.
