AN ORDINANCE TO AMEND that Certain Ordinance Entitled RACINE COUNTY ZONING ORDINANCE adopted December 2, 1969, found on pages 185 to 232 of the OFFICIAL PROCEEDINGS OF THE RACINE COUNTY BOARD OF SUPERVISORS FOR THE YEAR 1969 as recodified May 28, 1991, by Ordinance 91-196.

The County Board of Supervisors of the County of Racine ordains as follows: Amend the Racine County Zoning Ordinance and change the zoning district for the following described lands from A-1 Farmland Preservation to A-2 General Farming and Residential District II.

LOT 1, Racine County Certified Survey Map No. 2963, recorded in Volume 9 of Certified Survey Maps on Pages 563-565 as Document No. 2233602, being part of the Southwest ¼ of the Southwest fractional ¼ of Section 19, Town 4 North, Range 19 East, Town of Waterford, Racine County, Wisconsin.

ALSO: THAT PART OF LOT 1 OF CERTIFIED SURVEY MAP NO 3015 as. recorded in Volume 9 of Certified Survey Maps on Pages 776-778 as Document No. 2279565, being part of the Southwest ¼ of the Southwest fractional ¼ of Section 19, Town 4 North, Range 19 East of the fourth principal meridian, in the township of Waterford, Racine County, Wisconsin and described as follows:

**COMMENCE** at the Southwest corner of the Southwest fractional \( \frac{1}{4} \);

**THENCE** North 87°53'42" East along the South line of the Southwest fractional 1/4 of said Section, 1310.47 feet;

**THENCE** North 00°07'55" West along the East line of the West ½ of the Southwest fractional 1/4, 330.20 feet;

**THENCE** South 87°53'42" West, parallel with the south line of said ¼ section 444.25 feet to the Southwest corner of Lot 1 of Certified Survey Map No 2963 and the point of beginning;
