Sheriff Schmailing gave an overview of his Department. This included what his individual departments were concentrating. They serve court needs on the daily. They serve Protective Orders. Their rate of success is 99%. They have answered up to 74,000 calls from 1/1/19 to 9/1/19. They had 30,000 traffic stops in 2018. Jail Division Average Daily Population:748 in 2019. DOC has a 2-Million-dollar contract that creates positive revenue. Metro Drug Unit has been kept very busy. Criminal Investigation Division builds courtroom ready cases. He spoke extensively about Body Cameras. He took questions from the Committee.
