RESOLUTION BY THE RACINE COUNTY ECONOMIC DEVELOPMENT AND LAND USE PLANNING COMMITTEE TO AMEND THE TOWN OF YORKVILLE LAND USE PLAN FROM AGRICULTURAL, RURAL RESIDENTIAL AND OPEN LAND TO COMMERCIAL AND TO REZONE FROM A-2 GENERAL FARMING AND RESIDENTIAL DISTRICT II TO **B-3 COMMERCIAL SERVICE DISTRICT**

TO THE HONORABLE MEMBERS OF THE RACINE COUNTY BOARD OF SUPERVISORS:

BE IT RESOLVED by the Racine County Board of Supervisors that the Racine County ECONOMIC DEVELOPMENT & LAND USE PLANNING COMMITTEE, having considered the petition by Jon and Kay Erickson in the Town of Yorkville, County of Racine, State of Wisconsin; and having held a public hearing thereon pursuant to law and notice thereof having been given as provided by Statute; and being duly informed of the facts pertinent to the change proposed to the following described property:

A TRACT OF LAND being a part of the northeast ¼ of Section 20, Town 3 North, Range 21 East, in the Town of Yorkville, County of Racine, State of Wisconsin, bounded and described as follows:

COMMENCE at the center ½ corner of said section:

THENCE south 88°54'06" west for a distance of 1327.42 feet, along the north line of said $\frac{1}{4}$ section; to a point;

THENCE south 01°27'05" east for a distance of 367.3 feet, along the west line of the east ½ of said ¼ section, to the point of beginning;

THENCE north 75°25'54" east for a distance of 770.49 feet, along the center of C.T.H. "C", to a point;

THENCE south 01°27'05" east for a distance of 845.02 feet, parallel to the west line of the east ½ of said ¼ section, to a point;

THENCE south 88°58'21" west for a distance of 750.41 feet, parallel to the south line of the north ½ of said ¼ section, to a point;

THENCE north 01°27'05" west for a distance of 664.72 feet, along the west line of the east ½ of said ¼ section, to the point of beginning.

RESERVING the northerly 33.00 feet for public road purposes.

CONTAINS 15.003 acres, including road reservation.

HEREBY RECOMMENDS that the proposed amendment to the Town of Yorkville Land Use Plan from Agricultural, Rural Residential and Open Land to Commercial and the proposed rezoning from A-2 General Farming and Residential District II to B-3 Commercial District be denied, as this rezoning is not in the public interest and it will adversely affect the surrounding property values.
