RESOLUTION BY THE GOVERNMENT SERVICES COMMITTEE AUTHORIZING RACINE COUNTY SHERIFF'S OFFICE TO ENTER INTO AN AGREEMENT WITH THE FEDERAL BUREAU OF INVESTIGATION (FBI) FOR CONCRETE SLAB AND TARGETING SYSTEM REPLACEMENT AT THE ROBERT ROHNER RANGE

To the Honorable Members of the Racine County Board of Supervisors:

BE IT RESOLVED by the Racine County Board of Supervisors that Racine County Sheriff's Office is hereby authorized to enter into an agreement with the Federal Bureau of Investigation (FBI) to replace the upper concrete pad and the target system to the Robert Rohner Range and said final agreement will be on file with the County Clerk.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that the execution of the agreement and any addenda shall be subject to the review and approval of the Corporation Counsel and Racine County Sheriff's Office.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that the County Clerk, the County Board Chairman and/or the County Executive are authorized to execute any contracts or contract addenda to carry out the intent of this resolution.

20 **WHEREAS**, Racine County received \$1,436,737.61 from the FBI/Federal  
21 Government for capital improvements to the Robert L. Rohner Training Center in the  
22 Village of Caledonia back in 2004.

23  
24 **WHEREAS**, part of the funds that were received were used to design and  
25 construct an upper concrete pad and a pneumatic turning target system for the firing  
26 range.

27  
28 **WHEREAS**, the FBI/Federal Government has approved and allocated \$180,000  
29 for the renovation and replacement of the upper concrete pad and the target system at  
30 the Robert L. Rohner Training Center but before commencing said replacement the  
31 FBI/Federal Government is requiring an amendment to the 2004 Cooperative Agreement  
32 between Racine County Sheriff's Office and the Federal Bureau of Investigation for  
33 Construction of a Joint Use Firearms Training Facility.

35 **WHEREAS**, the Racine County Corporation Counsel and Racine County Sheriff's
