RESOLUTION BY THE FINANCE AND HUMAN RESOURCES COMMITTEE AUTHORIZING THE ACCEPTANCE OF A WISCONSIN DEPARTMENT OF TRANSPORTATION, BUREAU OF TRANSPORTATION SAFETY ALCOHOL ENFORCEMENT GRANT IN THE AMOUNT OF \$49,920.00 IN COOPERATION WITH KENOSHA COUNTY, AND AUTHORIZING THE TRANSFER OF FUNDS WITHIN THE RACINE COUNTY SHERIFF'S OFFICE (RCSO) 2015 GRANT BUDGET AND TRANSFER OF \$7,480.00 FROM THE RCSO 2015 BUDGET TO THE RCSO 2015 GRANT BUDGET

To the Honorable Members of the Racine County Board of Supervisors:

BE IT RESOLVED that the Racine County Board of Supervisors authorizes and approves the acceptance of a grant in the amount of \$49,920.00 from the Wisconsin Department of Transportation, Bureau of Transportation, Safety Alcohol Enforcement Grant, in cooperation with Kenosha County.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that the transfer of funds as set forth in Exhibit "A" (attached hereto and incorporated herein) is authorized and approved within the Racine County Sheriff's Office 2015 and the Racine County Sheriff's Office 2015 Grant Budget.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that all agreements shall incorporate such terms and conditions as the Corporation Counsel and the Racine County Sheriff deem necessary and appropriate.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that any two of the County Clerk, the County Executive and/or the County Board Chairman are authorized to execute any contracts, agreements or other documents necessary to carry out the intent of this resolution.
