11 **TO THE HONORABLE MEMBERS of the Racine County Board of Supervisors:**

13 **WHEREAS**, the Trimble Geo 7X is a fully integrated handheld system for GIS data
14 collection, asset relocation and mobile GIS applications and extends the reach of
15 traditional handheld data collection by integrating a laser rangefinder module; and

17 **WHEREAS**, the Trimble Geo 7X module is compatible with software currently being
18 used daily by the Land Conservation Division; and

20 **WHEREAS**, a Trimble Geo 7X handheld and rangefinder module is available from
21 Seiler Geospatial Division for a quoted price of \$11,658.50; and

23 **WHEREAS**, there are sufficient funds in Public Works and Development Services
24 Account Number 66.1584.321, Reimb Tank Refunds, in the amount of \$11,750.00 to cover
25 the cost for the purchase of a Trimble Geo 7X handheld and rangefinder module.

27 **NOW, THEREFORE, BE IT RESOLVED** by the Racine County Board of
28 Supervisors that the purchase of a Trimble Geo 7X handheld and rangefinder module,
29 with Trimble access, is authorized and approved, to be funded as set forth in Exhibit "A"
