13 Sections 12-46(1) and 12-46(14) of the Racine County Code of Ordinances relating  
14 to speed limits on County Trunk Highway (CTH) C is hereby temporarily amended to read as  
15 follows:

17 **Sec. 12-46. - Modified restrictions on county highways.**

19 (1) County Trunk Highway C.

- 20  
21 I. (Also known as Spring Street) Thirty-five miles per hour for all vehicles from a  
22 point eight hundred fifty (850) feet east and west of its intersection with  
23 County Highway (CTH) V.

25 (14) County Trunk Highway V.

- 26  
27 I. Thirty-five miles per hour for all vehicles from a point eight hundred fifty (850)  
28 feet north and south of its intersection with County Highway (CTH) C.
